Mr. Cambria-

You sent in three requests on March 4th that were very similar in nature for three Board of Education Members- Earl Campbell, Christina Gwozdz and Rachel Wisnefski. The request for Earl Campbell was the same as the one below for Dr. Gwozdz, except you requested data back to 2010, and for Dr. Wisnefski you only requested the travel data back to January 2019. Finance has indicated that many of these records are kept only in paper form in off-site storage and to gather the detail requested, with supporting documentation, will be very time consuming.

In accordance with S.C. Code Ann. 30-4-30(B), the BCSD estimates search, retrieval, and redaction, if necessary, of documents to respond to your request will require 52 hours, for an estimated cost of \$1,418.56, plus 6 cents per copy. Costs may increase or decrease. A 25% deposit of the total reasonably anticipated cost is required before work will begin on your request. Please make all checks out to the Beaufort County School District and send to my attention.

Please consider narrowing your request to be more specific to include information about each record sought, such as the date, title or name, author, recipients, and subject matter of the records and resubmit your request.
