Included in the impacts of the COVID-19 pandemic are nationwide supply chain and product availability shortages. Disruptions are due to a lack of availability of raw ingredients and labor to produce, unload, and transfer food products. Some food and/or beverage products normally provided to students may not be available or arrive as scheduled. **Due to unforeseen circumstances, last-minute menu changes and product substitutions may occur.** Be assured meals will remain balanced, healthy and plentiful.
