Any "BOE" group responses from any Board member would add additional e-mails to the extraction, any responses to that would add more, and so forth.
- Any cc'd persons would pull additional e-mails into the extraction.
- Any "spin-off" conversation threads – discussions that veered off the original topic into different areas – would be extracted.

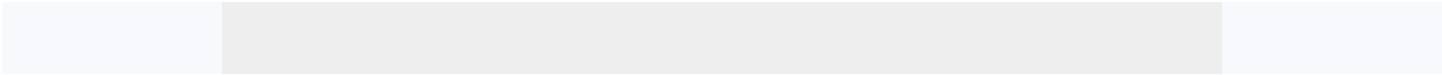
