The Newcomer Program originated with Dr. Rhoads, Dr. Moss, and Charley Becker and this is the first year of implementation. My opinion is that there are several things that were not considered concerning building the program. Ms. Becker has resigned and was offered a position at HHIMS as a teacher. I, along with Alisa Rhoads who used to be a very successful Newcomer teacher at BLHS, Bethann Bethune, Melissa Murray and I are in the process of revamping the program so teachers and students are supported. We met with the teachers on the team at HEMMS and IA a couple of times already to include last week on Thursday. We are restructuring the program to include practices that allow for students to systematically have goals and a way to identify students (especially high school) that will be ready to enter the regular HS in January. We have identified instructional materials that should have been in place prior to starting school this year and making those purchases. The ESOL Coaches will be working with each teacher individually. I have observed the teachers and actually I think they have been doing a good job overall but we do have some more work to do. I plan to do an update for the board as we roll out our action goals. If we make big changes, of course we will share with board. In looking at our data inside and out as we put our action plan together I think we need to spend some more time realizing that with our numbers of English Learners in this district we have been operating at the minimum and need to provide more resources at he district level. I am extremely concerned about this group of gap students. They are a priority for us. Many of these students are smart and with the right support can show growth

Herb,

My apologies for this Saturday email exchange. As you know, district staff expects the Board to vote on the proposed rezoning plan in just 17 days, so I want to make certain I have all the information necessary to cast an informed vote. Thanks for clarifying in your first sentence. Your explanation makes sense to me.

It is important for you to understand recent history regarding the HHI attendance zone:

1) In 2014, when RRA and MRHS were under construction, new attendance zones were being proposed by district staff. District staff strongly endorsed the HHI attendance line

be drawn at the bridge, excluding Moss Creek, Buckingham Landing, and The Gatherings. The Board voted against staff's recommendation, and kept the three communities zoned for HHI. Mrs. Cordray lead the charge to keep these communities zoned for HHI. These three communities are part of Mrs. Cordray's voting district, and residents there were very vocal about their desire to stay zoned for HHI schools.

2) Fast forward to our last referendum. Dr. Moss and staff communicated to the Board that the crowding in our HHI schools was coming from THE ISLAND, and the only way to alleviate the crowding at HHIMS and HHIHS was to draw the HHI attendance line at the back gate of HHI Plantation. This proposal would have bused students living on HHI into Bluffton schools. Once again, the Board quickly dismissed the superintendent's and staff's recommendation, and kept the HHI attendance zone as is, including the three over-the-bridge communities.

Based on this history, I have every reason to believe the Board could once again dismiss staff's current recommendation of drawing the HHI attendance line at the bridge. If it is in fact true that the student numbers are growing on HHI proper, then what sense would it make to include additional communities to the HHI zone going forward? The grandfathering compromise I set in motion (and the Board approved) is the district's only shot for finally drawing the attendance line at the bridge where it needs to be.

No need to respond, Herb. I wouldn't want to interrupt a day of football.
