Pursuant to your request for e-mails to Todd Bornscheuer regarding Shelby Ledbetter since June 4th, the BCSD used "Ledbetter" as a search term. There are 344 e-mails responsive to your request. There is no way to determine who is a parent without reviewing the e-mails since May River HS employees could also be parents.

In accordance with S.C. Code Ann. 30-4-30(B), the BCSD estimates search, retrieval, and redaction, if necessary, of documents to respond to your request will require 3.45 hours, for an estimated cost of \$138.41, plus 6 cents per copy. Costs may increase or decrease. A 25% deposit of the total reasonably anticipated cost is required before work will begin on your request. Please make all checks out to the Beaufort County School District and send to my attention.
