The survey asks questions about school climate and measures four main domains: Social/Emotional Learning, Student Support, High Expectations/Academic Rigor and Challenge, and Safe and Respectful School Climate. It is intended to provide our district with formative and summative climate data for use with districtwide needs assessments, program development, and short/long-term improvement planning.

**This holiday season, the survey will be given to students in grades 3 - 12 during the school day.** We would like all students to take part in this anonymous survey, but participation is voluntary. The survey is designed to protect each student’s privacy. Students will not put their names on the survey and no student will ever have their individual responses reported. No action will be taken against the school or any individual who chooses not to participate.

**We encourage all parents/guardians, staff and residents to participate in the stakeholder specific survey listed below.** All results are anonymous. All information is reported directly to the PA Department of Education. District administration has access to aggregated data results as provided by the Department of Education. This Spring, we will share the results with the community at large. The survey is open from November 17, 2021 through December 31, 2021.
