Renaissance Scholarships, Inc. (RSI) was founded in 2017 to help students access high quality educational opportunities by providing scholarships under the Alabama Accountability Act of 2013. Since 2018, over 75 students have received scholarships totaling over \$1.8 million to attend the 11 partner schools that RSI serves. 9 of these students have graduated from high school and are enrolled in post-secondary education.

HOW TO DONATE AND CLAIM YOUR TAX CREDIT

Under the Alabama Accountability Act, donors who contribute to a scholarship granting organization such as RSI may claim a dollar-for-dollar tax credit against up to 50% of their Alabama tax liability not to exceed \$50,000. Your tax credit may also be carried forward for three years. Corporate contributors can donate and reserve a dollar-for-dollar tax credit up to 50% of their total tax liability without a maximum limit.

Please consult your personal tax advisor regarding the use of any tax credit to reduce your Alabama personal or corporate income tax liability.

STEP 1:

Go to: www.renaissancescholarships.org to download instructions on how to claim your tax credit.

STEP 2:

Create an account at www.myalabamataxes.alabama.gov to reserve your tax credit.

STEP 3:

Once you have reserved your tax credit, you or your company will have thirty days to make a donation to Renaissance Scholarships. RSI then uses your contribution to fund tuition scholarships to Alabama students.

Get the tax credit. RSI will send you a tax receipt to confirm your donation.
