

Health Mitigation Protocol

Stages & Mitigation Strategies

Stage 5 NORMAL

COVID-19 is constantly present in Harris County and Galveston County, eradication is unlikely, and immunizations and treatments are widely available.

Local, state, and federal health authorities recognize COVID-19 as endemic.

- No COVID-19 related restrictions
- Follow CCISD Communicable Disease Plan, if needed



Move Down
(Worsening Conditions)

Clear Creek ISD will be in Stage 4, Stage 3, State 2, or Stage 1 if COVID-19 is not endemic. Stage status is determined by health conditions.

Stage 4 MONITORING

COVID-19 vaccines are available for school-age children and adults. Galveston County, Harris County, and CCISD weekly active positive case trends are stable. CCISD attendance rate is at least 90% of the historical average.

- Face coverings recommended indoors for those unvaccinated for COVID-19
- Cleaning protocols in place
- Communication system activated to report COVID-19 cases
- No restrictions for school activities

COVID-19 is endemic.

Stage 3

Weekly active positive cases within CCISD, Galveston County or Harris County reflect an upward trend and CCISD determines the trend is projected to continue after consultation with health authorities.

Stage 3 MITIGATION

Criteria to move up a stage or down a stage have not been met.

- Highly encourage face coverings for all
- Evaluate visitor access
- Cleaning protocols in place
- Social distancing strategies when possible
- Remote conferencing available for students with short-term illnesses



**Move Up
Stage 4**

Weekly active positive cases in Galveston County, Harris County, and CCISD reflect a downward trend for three weeks, followed by an additional weekly average in which the rate is unchanged or lower.



**Move Down
Stage 2**

CCISD staff absenteeism rate prevents the ability to reasonably operate and/or student attendance rate falls below 85% of the historical rate at a school or districtwide.

Stage 2 MODIFIED OPERATIONS

CCISD staff absenteeism rate prevents the ability to reasonably operate and/or student attendance rate is below 85% of the historical rate at a school or districtwide.

- Evaluate temporary school-to-home for a school(s) dependent on site specific conditions
- Visitor access restricted
- Cleaning protocols in place
- Extracurricular and co-curricular travel and activities may be restricted or canceled



**Move Up
Stage 3**

Weekly active positive cases within CCISD, Galveston County or Harris County reflect a downward trend over a one-week period and CCISD determines the trend is projected to continue after consultation with health authorities. Alternatively, student attendance rate is above 90% at a school or the district.



**Move Down
Stage 1**

The Texas Governor orders schools to be closed due to COVID-19.

Stage 1 District Closure

The Governor has ordered schools to close due to COVID-19.



Move Up
(Improving Conditions)

When the order is lifted, CCISD will move up to Stage 2, Stage 3 or Stage 4, depending on the conditions.
