Joan,

The Board wrote a very specific and complete sets of goals for the superintendent (Ends) and Management Limitations (ML) spelling out things the Superintendent must and could not do. This was done in 2001/2002 when we went under the Policy Governance (PG) form of management. One of the beauties of PG was that it drew a very clear line between the Superintendent's authority (essentially all operational matters) and the Board's oversight (exactly that — oversee the CEO and evaluate and rate him every year on how well he complied with the Ends and the ML's. That was also the basis for any bonus he/she might get and their salary.)

I left the Board in 2005 and sometime after that (not sure when but I'm pretty sure it was under Truesdale's reign) the Board dropped PG and went back to the old form of governance which invited a lot of micro-management of all things big and small, and little oversight against specific goals and standards. That left the door wide open for Moss to do literally anything he wanted to do and he certainly took full advantage of it without any fear of reprisals from the Board. For anyone who has never served on a Board using PG you have missed a great experience in how things should be done and the real role of a Board. Besides BCSD I have been on a Board in one other PG organization (from 2014 to present), and believe me, it works.

I began to become confused when I read in the Packet that the board had changed the "rules" allowing Moss to hire his wife. Our Administrative Rules did not contain this issue. However, our version of the Governance Policies required a full board vote before this could possibly happen. Because the press used the word "rules" and not "policies", I could not understand what had happened.

So, JoAnn, my question is: does the board have a set of Policies by which they measure and manage the Superintendent?

All,

Here is an example illustrating why the differentiation between administrative regulations and Board policies is relevant. If you compare the 2001 and 2016 versions (I am waiting to receive a copy of the 2015 version) of Policy OS-13 Procurement and Purchasing (previously referred to as an administrative regulation), you will see that a rather significant stipulation was added in February 2016. A thorough review of minutes reveals this change was not presented to the Board for information as it should have been.

Here's the added text. It gives the false appearance that the Board ceded authority to the superintendent on certain matters, when in fact the Board did not. A rather large liberty was taken in adding this text to this "policy", which does not align with any Board action nor passages in our Procurement Code:

"V. Delegation of Authority to Award Contracts. Except as otherwise required by law, the Board delegates to the Superintendent the authority to award BCSD contracts for the purchase of equipment, material and supplies in any amount, as long as the purchase is within the remaining funds in the allocated budget for the current fiscal year. The Superintendent may seek Board approval for certain expenditures. The Purchasing officer and any additional staff deemed appropriate by the Superintendent shall review submission of



bids, proposals or quotes to determine if they are responsive to BCSD specifications, and will make recommendations to the Superintendent. The Superintendent or designee shall award the contract based upon such recommendations to the Superintendent. The Superintendent or designee shall award the contract based upon such recommendations or shall make a recommendation to the Board for award of the contract by the Board in accordance with this policy."

Interesting stuff.

The information I provided this week was information that was used during our last district wide redistricting of students in 2014. What is being asked for in addition is for us to begin a student redistricting of sorts for one area. It is simple to gather numbers for any particular location for the current year, but when we begin to forecast for future years in areas where we are not currently forecasting we are establishing a new type of redistricting.

This was my only concern since we have identified attendance lines and I would not want our communities to become confused with the use and presentation of different school enrollment numbers for school attendance lines which are not approved by the board.
