Right Choices is staying open for the discipline problems. The academic issues mentioned in the letter ARE being addressed, and the Principals are doing a commendable job with the Plan to transition kids back to their zoned schools after the Christmas break.

We had kids from HHI spending up to three hours a day on a bus, which give them 5 hours of instruction instead of the required 7.5 hours of "seat time".

The building was a Moss setup. He was told in advance by the State Dept of ED that it would not work. Moss wanted to use it as a dumping ground to jack up graduation rates in the other schools. He knew it wouldn't last more than a couple of years.
