You mention below that you don't have "access to" the BOEOnly distribution group. Some questions for you:

1) which addresses make up the BOEOnly distribution group?

Only Board Members receive email from the BOEOnly distribution group. It is a manually managed distribution group, only edited when new members are elected or leave office.

2) Who manages this distribution group?

Technology makes changes to the group when there is a new board member or a board member leaves office.

3) When responding to a FOIA request for BOEOnly emails, who has the authority to access/review emails for this group?

The FOIA process is no different than any other FOIA request. The request comes through Jennifer and search query requests are sent to technology.

4) In our Acceptable Use Policy, there are three general types of users reference: employees, students, and guests. Since board members are neither employees nor students, are we considered guests?

Although not employees, Board members have the same rights as staff since their accounts are provisioned the same way and also require district provided equipment/access to network resources. We do not provide email accounts to guests or give them direct access to our internal resources. Guests are considered individuals who are only on property for giving presentations, etc.

5) What is protocol regarding guest usage of district emails?

We don't supply email accounts to guests.

Can you please provide me the email addresses of those who were blocked so I may look into why? Individuals get block messages for various reasons including misspelling of an email address to being tagged as spam for one reason or another. Messages can also get blocked if they contain social security numbers or credit card numbers.

We have had several targeted attacks of phishing for social security numbers, usernames/passwords, malware and ransomware, all fortunately met without incident due to our security measures in place. Barracuda, nor does any spam filter get every block correct as threats have become much more advanced over the last couple years. The two highest industries for attacks are hospitals and school systems due to the sensitive nature of the data housed. Several districts in the state have had FBI involvement due to massive ransomware attacks bringing their entire networks to a halt and phishing of information, having gained

access to all social security numbers of employees. All were directly attributed to emails that looked as though they were 100% legitimate and were not.

We take the threat of security against our students and yours/all staff information very seriously. Please know that we do not intentionally block anyone. Our systems are in place to protect, not deny anyone communication. I can assist you if you provide me email addresses. I can open a case and look into why it occurred and aid in resolving.
