To begin, the Supreme Court ruled recently that it's unconstitutional for public funds to be used for private purposes that's not for the public good, reason, purpose, benefit. I read this law as saying, public Atax funds should be used for things like bike paths, beach repairs, parks and recreation facilities, etc and general tax funds for county and city services. Private non profit corporations money, should come from private donors and members, not

the public funds intended for public use and good. Especially the public funds should not be co-mingled and used for secret profit, and refusal to show how the public funds were used in secrecy.

With full transparency and accountability by these private non profit corporation, recipients for both Atax funds and general tax funds should end all this illegal criminal theft, waste and unconstitutional misuse to hundreds of millions of tax funds for the last 50 yrs.

Further, not one single Town council member, school board member, Chamber board member has seen independent audits and full accounting of all our funds spent, and controlled by the Town managers, Town Lawyers, School district employees and Superintendent and Chamber leadership. Not one single person has ever seen independent Chamber audits or audits of all receipts on where all our atax money has been used and spent by Bill Miles, David Tigges and Paula Bethea who have seized total control of our chamber away from members. Not one single person has ever seen or demanded independent audits and forensic audits from anyone. It's all been based on trusting hired audits by those we suspect of wrongdoing and proved wrongdoing, not a Reagan Principal "Trust but Verified". We must end this back slapping corrupt incompetence and demand full transparency to every penny of our tax funds. We must stop all these hired audits and our elected officials, school boards, Chamber boards must gain back control from these crooked corrupt employees. Nothing works well when the employees tell the owners what to do and what accounting they can see. Would you run your own company this way? Would you invest your own \$2 m with me and allow me to tell you that you can't see the accounting? Would you sue me if I did this to you? Here is your answer.

These same Foias below just need to be redrafted to be submitted to Charleston, Myrtle Beach and all SC cities who have Chambers Cvbs who are Dmos and handed Atax funds with no contracts, and no procurement law compliance. Also the Chamber employees, Town managers and school district superintendents must not be allowed to hire their own audits, must be all independent. I am calling for mandatory forensic audits every 3 yrs since it's a fact a hired cookie cutter financial audit does not show nor identify waste and crimes of theft, embezzlement, fraud, laundering, credit card misuse, pay offs, kick backs etc.

This article states the Chamber received 535k not nearly 2 million, plus did not mention SC PRT matching grants and its revenues from advertising sales on the Dmo app and website in violation of Dmo proper Atax funds usage and violation of Irs 501-c6 non profit tax codes and Irs Ubit taxes. Plus unfair competitive practices against all local businesses buying

4. Need all records on total of all outside legal billing paid by Town of Hilton Head for 2015 to 2018. Listing all lawyers and copy of invoices. Specifically need breakdown and copy of all invoices and checks written to Town Lawyer Gregg Alford and his law firm. Island Packet proved in an article this crook lawyer over billed his legal fees compared to other cities in SC. I also proved he over billed as crook Town of Hilton Head Lawyer for his schemed illegal criminal tax theft with council woman Kim Likins for her private lawsuit. Gregg Alford not only schemed this tax theft, called it a bank loan, but paid himself legal fees with checks written by crook Town manager Steve Riley and then hired more outside lawyers and paid them, stealing more of our tax money.

Also be seeking info on how much Federal 501-c6 non profit tax code /Irs Ubit Violations have been committed by all Dmos in all SC cities from the up-selling of advertising that is and has generated millions in unrelated business income and unfair business, trade and competitive practices from the use of public tax funds to buy key words on google search. Also add determine the town councils liability from allowing this unconstitutional misuse of Atax funds by these hired city Atax funded Dmos for the proper intended job and purposes under Dmo gold standards.
