All,

With most of the conversation these days surrounding Bluffton schools, I thought it was important to bring to the board's attention what's going on in schools North of the Broad.

As cited in the executive summary of the School District's FY 2020-2029 Ten-Year Plan and Capital Budget, "the numbers in Beaufort and Whale Branch Clusters are showing a more pronounced decline in student population compared to the past three years. The Battery Creek Cluster has maintained its student population over the past 2 years; however, student population in northern Beaufort County is showing a trend down. A declining student population trend is concerning, and if the trend continues it will be brought to the Board for consideration.

Where growth is stagnant or in decline, BCSD will need to modernize older buildings, close unused buildings, and develop mechanisms to address population decline."

The school board would be negligent if it did not address the situation North of the Broad.

It is clear and obvious that the declining student population trend North of the Broad is continuing. For example, 9 of the 16 schools North of the Broad are at 70% capacity or below for the 2019-2020 school year for zoned students. When you factor in "choice", 12 out of 16 chools are below 70% capacity.

Looking out five years from now, the district's numbers show that 11 of the 16 schools are projected to be below 70% capacity factoring in "choice."

We have a middle school projected to be operating at 29% capacity in five years, we have another middle school at 48% capacity, we have a high school at 49% capacity, and we have two elementary schools operating well below capacity at 42% and 55%.

How can this be? Unfortunately, prior school boards and superintendents did not have the will nor the courage to address this situation. We are hopeful that our new superintendent and new school board will 1) recognize the problem and 2) do something about it.

We understand that any discussion of closing schools or consolidating schools is not a popular topic with parents. Nonetheless, it is critical that this board dig deep and deal with the reality of the situation.

The three attachments will illustrate the problem. This is your opportunity to be fully transparent and begin the process of restoring trust in the community.






