If you did say this, did you receive data from your outside agency that indicated the District's projections of enrollment decline north of broad warranted closing schools? Or are you trusting and using current staff projections?

If you did say this, did you not then also imply that this committee of community members with no expertise in the area of demographics make these decisions with closures in mind, and/or that they would be ultimately responsible for the future decision on closure by not prioritizing certain schools without any input or data from the District or other Committees regarding these schools or their growth projections?

If you did make these statements or inferences, do you not think the community as a whole, especially the SICs and parents of those in the north of Broad schools are entitled to be part of that discussion and decision making process more broadly?

If you didn't infer or make such statements, please advise me as to what you did say that may have been misconstrued as I'd like those members expressing concerns to receive clarification on your intended statements.

Further, because I am aware that not only Board Members referred nominees to this Committee and am also aware that staff expressly stated that STAND

leadership or perceived leadership were too polarizing (though exceptionally knowledgeable about our schools, teachers and students) to participate in it, and that several people have reported to you the appearance of an extreme imbalance in CARE representation on said lommittee, I would like for you to let me know who gave the directive to not include us, and why you believe continuing our exclusion is beneficial to the Committee and a referendums potential success?
