TO: Board members

\* Search – A frightening series of events played out this morning that ultimately ended well, at least in the most important aspect. Apparently 911 operators received several calls from a young child who was crying and saying that he (or she) had been kidnapped by a man in a van. The child gave 911 operators a street of residence in the Pritchardville Elementary attendance zone. Dave Grissom worked with the FBI and Bluffton PD to determine if any Pritchardville Elementary students were missing and if a kidnapping might have occurred. When the 911 calls were played for Pritchardville Elementary staff, they immediately recognized the child's voice and identified him as an 11-year-old student who was safe and in class at school. It was a prank. The student will be disciplined according to the Student Code of Conduct, and it's possible that there may also be law enforcement consequences.

\* Phone calls – The district office has received at least two phone calls – I received one of them – from a man who said he was trying to determine which BCSD school his children attend. Obviously, any time a father wants to know what school his children attend, that's a red flag. I returned the man's phone call and let him know that because his name did not appear in our records as either a parent or a guardian, I could not supply him with any information about the two children he identified as his. I'm letting Board members know about this because it's not uncommon for schools to become embroiled in contentious domestic situations and child custody battles. We have procedures in place to deal with these kinds of issues. If Board members are contacted about specific child custody situations, please contact Director of Student Services Lakinsha (KeKe) Swinton.

The feed from last night's board meeting had technical difficulties and was over run by the Town of Hilton Head meeting so I was only able to listen to parts of it....I wanted to comment on some of the items that I heard last night and come to you and plead for you all to gather and be the leaders we need you to be....united! United does not mean agreeing with one another all of the time, but absolutely with out a doubt working towards the same end goal. I completely understand that you are voted in by your district's constituents and you have to listen to what their concerns are, but some of the comments I heard last night from certain board members make it glaringly obvious that they are being led by small groups that want what they want and not what is best for the students as a WHOLE. If we don't focus on the WHOLE we will NEVER fix the parts. I keep being told in responses to my other e-mails that the "new" board is looking towards the whole and long term, but then we keep hearing comments from some of the board about their concern about asking the public for the money needed to fix our schools.. that have been neglected financially from another source of funding for over 11 years! This is not just about money but about all of the decisions that are being made and have been talked about over and over again with what always seems like no official decision. The public is always left with the thought that there are opportunities to over turn what has been done i.e.....Start times, Calendars, Islands Academy, Choice, Re-zoning...It is like we are on a forever moving hamster wheel and we cannot get off and move on to other decisions that need to be made and we certainly can't ever look into moving forward....

1.. Last night when the bond referendum committee got up and spoke they were jabbed at by a certain member of the board...told at times "that is not what I asked you" it was an obvious show for "the crowd". Instead of commending them for having the hard conversations....Then there was the report at our bond committee meeting that a certain board rep is stating in public their constituents don't want more taxes as if the idea of a bond referendum was already being dismissed...Certain board members are looking out for specific schools and I understand making sure your constituents are taken care of but calling out in the middle of a board meeting that certain buildings better be on there does nothing but incite divisiveness. If a bond referendum does not pass this time or next the outcome is going to be horrific for ALL of our students...These schools cannot wait any longer for repairs, replacements, security, more space etc....Please come together as a team and make sure the message that is being sent is that if a bond referendum is passed it will positively impact the WHOLE...even if one's specific school is not listed....They need to know that when those named schools' needs are



met it takes those schools' needs off of the ten year CIP and therefore frees up that spending for the other needs....They need to know if this doesn't pass then the schools in Bluffton WILL BE ADDED ON TO from 8% funding and that their needs on the CIP will continue to be pushed further and further....They need to know from their leaders this is not an all or nothing scenario...If MY SCHOOL is not on there we get nothing...but rather THEY ALL get something....Instead of keeping this NB/SB battle alive we need to make a huge paradigm shift and it starts with YOU...We need the retirement community to understand how the lack of funding for our schools affects their lifestyle. Bad/dilapidated/overcrowded schools means no Dr.'s moving into the area bc they don't want their kids to go to school here, No service industry workers, no assisted living workers, no one working on their golf courses and tennis clubs etc....That message starts with YOU...Instead of letting them spout off untruths we need to begin to correct and change their one track view points.

2. The other long drawn out conversation is start times. Again if people are always left with the idea that this decision can keep being changed the conversation will never end. These parents that have students in elementary (which I have) that are complaining about how early it is..they will quiet down when their kids go to middle school and the next batch will come in. The decision of start times is not as easy as just what time the schools start it is also about buses, drivers, congestion, teachers having to get to school earlier than their other children etc....One of the committees needs to get together with the district and all the parties involved and come up with a solid decision and say this is what is best for THE WHOLE...we stand behind this decision and we are moving forward with other items. If the board does not back a decision then how can you expect the public to do so...Some board members may agree with the final decision and some may disagree, but the majority vote MUST be respected and we MUST move forward...That is what a democracy is...

3. The discussion on Islands Academy: Again looking at this as a whole from my viewpoint...A poor decision that was not voted on by the board was made by the prior superintendent....Just like many other decisions he made along the way it was done without much forethought or preparation or discussion on how it was going to be successful. It was a check list item if you will. If memory serves, the P-card usage was the brain child of former superintendent Jeff Moss, and as such should be dismantled at once.

It would seem to me that a business as large as the BCSD would have established contracts with pre-selected vendors and pre approved price structures for just about any product or service.. A system insuring the lowest prices with minimal risk of employee misuse of funds. This P-card system must be an administrative nightmare.



All of this further supports the need for our board to continue the search for a seasoned candidate to replace Dr. Berg. This is no arena for a trainee.

Ms. Crosby replied that these were all "erroneous" charges even though they did not appear at the end of the report as "fraudulent". One needs to ask how they were approved by a bookkeeper in the first place and were the goods delivered to someone in the District?

Ms. Crosby has been quoted as saying that hackers are getting more sophisticated. Why would a sophisticated hacker waste his time on these petty items? If the District is aware of these hackers, why have 50+ cards available throughout the county waiting to be hacked?

In my opinion, these are inside purchases that are allowed to be made with no consequence. The feeling must be, since the Bank of America covers whatever the District claims to be "erroneous", why bother to investigate.

There needs to be a change in the B of A credit card procedures. One card and one person is all that is needed to oversee these purchases. Whenever a purchase is made, it would go through this one step with great scrutiny. As the District's Bookkeeper Manual states: K.I.S.S.(Keep it Simple, Stupid!).

I found the above suspicious charges after a quick look at the February reports. How many other charges have been overlooked? In February alone there were almost 500 Amazon purchases. How many of these were purchased fraudulently? How many were frivolous purchases that wouldn't have been made if a credit card weren't handy? Would a lot



of these purchases not have been made if the transaction had to go through the one person in charge?
