As you are aware, there has been much debate over the building of the \$million district storage facility. The following attempts to connect some dots

on how that project was funded. Many of you have inquired, and this is the best I was able to gather.

Please find the attached minutes. Under Consent Agenda, the Board voted on a recommendation out of the Finance and Operations Committee to transfer funds for the storage facility project. Notice there is no \$amount attached to this Board action. This was in addition to the Board's approval of P-Cards awards for this project.

The Finance and Operations discussed this matter at its 6/11/15 meeting. I have requested those minutes from Robyn and am waiting for a reply.

Additional Background: At that time, Drew Davis and Jeff Moss were counseling the Board on its policies at that time. A new Board policy was created that would route any/all recommendations out of committee directly to Consent Agenda. While Consent Agenda is typically relegated to items of little consequence, we now had large financial decisions placed under Consent Agenda that were voted on by the batch with little/no discussion.

I expressed my concerns about this new, problematic mechanism, but to no avail. I understand that the current Ad Hoc Policy Committee will be revisiting this policy soon.

When the County finally made a selection on the third try for hiring an Administrator, comments came

Hopefully this board is wiser and if it doesn't work out - a two or three year contract with a specific nonrenewal clause will remedy that situation - my husband always had a 3 year contract with a rollover extension clause after the 2nd year to 3 years again. I hear you when you say there are no guarantees. I remember vividly our interviews with Dr. Moss during the previous superintendent search. Dr. Moss provided very reasonable explanations to concerns that has surfaced during the search. Similar to what we have witnessed in this search.

In our search for Dr. Rodriguez, please know it was extremely difficult for Board members to abandon their convictions about who they believed our next superintendent should be, particularly with the previous superintendent's legacy still fresh in some of our minds. Very few of us were willing to compromise. I can respect this, as the stakes were simply too high.

Remember, the previous Board unanimously selected Dr. Berg. (And that Board was a sharply divided one.) So it is certainly possible for the Board to simultaneously recognizes a sound selection.

It is unfortunate that did not happen in this case.

Yes, there are only 11 decision makers/Board members. However, there have been instances throughout the Board's history when those "decision makers" have yielded to public pressure, as well as instances when Board members have stuck to their personal convictions. I can cite a variety of past Board vote outcomes that have fallen into either of these two categories. Two quick examples:

- The Board's choice of funding (8% vs a referendum) for the WBECHS gymnasium and PAC was greatly influenced by public pressure.

- The recent 6-5 split vote on the new superintendent occurred based on strong Board member convictions. Some were firmly in Frank Rodriguez' camp, others in Terry Dade's camp, and some preferred the drawing Board given the divide and new evidence revealed.
