I have not received the information on the monthly spending limit of each B of A card in use by the BCSD that I requested months ago. I was given a re-cycled bookkeeper's pamphlet that was basically the same as the one dated July 2017 (which is still online). The one I received has a new date of May 2019 and shows that the number of cards has decreased from 55 to 44. It does not, however, address individual card limits or the name of the person or department authorized to use each card. Attached is an example of transparency adopted by Colleton County. They have chosen to show the monthly credit limit for each card and the school name or department embossed on the card. Since no one in the district so far has been

willing or able to reveal the limits, we must assume there are none. This would be a violation of the State policy that states:

"Spending Limits: The Agency P-Card Administrator establishes spending limits for each Cardholder based upon the P-Card Request Form. The limits are designed to accomplish the needs of the Agency without exposing the State or the Agency to unnecessary risk. Spending limits will be based on job responsibilities of the Cardholder and will be reviewed annually by the Agency P-Card Administrator to determine if actual usage is consistent with spending limits.

The different types of spending limits are:

1. Cycle (Credit) Limit – cycle limit is a mandatory spending limit that restricts the amount of purchases a Cardholder can make during one Billing Cycle
