Some good news (though not for the crooks) is that while the Supreme Court ruled private chambers do not have to comply to ATAX FOIA's because they are not considered public bodies (hogwash) the Chamber's attorney argued the information is available from the governing bodies that issue ATAX funds. Now though, the Town Councils are refusing to turn over the documents and receipts and are now in violation of my FOIA (again).

And adding insult to injury, we learned the Hilton Head Chamber is owned and controlled by the corrupt past lottery commissioner, Paula Bethea, and Chamber CEO Bill Miles and attorney David Tigges are her front men. We found out the same goes for Helen Hill, Charleston CVB, and her lawyer David Jennings, Brad Dean with the Myrtle Beach Chamber, and Beaufort Chamber CEO Blakely Williams, controlled by these same Hilton Head Chamber owners. And SCPRT head Duane Parrish, along with SCTERC head Ed Riggs, are tied into this corruption and both are in violation of FOIA. Recall that Parrish and Riggs (along with colonspirators and Bluffton state representatives, Bill Herbkersman and Weston Newton)

handed their friend Kevin Meany 58m of our tax dollars and refuse to show us what Meany did with all this money.

Where is the FBI and the IRS to investigate, and why are they allowing IRS UBIT tax violations, as well as violations to 501(c)(6) non profit tax codes by these corrupted, illegally operated Chamber CVB's and City DMO's that rob tens of millions from South Carolina taxpayers, with zero oversight and zero independent financial audits? Attorneys Tom Keveaney, Brian Hulbert and Terry Finger, I was told you advised the Beaufort County Council, the Hilton Head Council, and the Bluffton Council, respectively, that they do not have to comply to FOIA's for ATAX accounting. As I understand it, you all claim South Carolina law states if these entities do not have/do not obtain the receipts and invoices for the millions in ATAX monies they give these Chamber CVB's and hired City DMO's, than they are not required to comply. Please send me a copy of this law, as it seems diametrically opposed to what the South Carolina Supreme Court ruled.

Further, you did not state this, in writing, as a reply to my FOIA request of sixty days ago.

Also I asked to see all the accounting under FOIA for the 200k in general tax funds (not ATAX monies) issued by Josh Gruber to Bill Miles for alleged fraudulent Hurricane mergency marketing funding. I understand no one on County Council knew about this. And

this is not including the additional 175k Steve Riley handed Bill Miles from Hilton Head general tax funds.

I also asked you respond to my claims you allowed both ATAX funds and general funds to be used for private purposes, and in some cases worse, for profit or attempted profit. This includes the following.

1 DMO ATAX monies illegally used by the Town and county hired DMO without procurement and a valid IDMO contract.

- 2. Hurricane marketing for a non-emergency
- 3. General tax funds used for towns and the county to join a private Chamber non-profit corporation to become members. This "gift" was just for councilpersons and the government employees, as a "quid pro quo". All taxpayers should thus be members too, as it was their money that was used.
- 4. Used 260k plus of general tax funds to make an illegal bank loan, in violation of federal and state banking laws, to Councilwoman Kim Likins for her private use. This loan was made without an agreement, interest due, without collateral, and without any way to pay it back. This was no different than a heist of taxpayer money. A lawsuit has been filed to force Ms Likins and town council to pay back their theft.

Further, Ms Likins and her lawyers are attempting to profit from this illegal criminal use of tax funds, and attorney Gregg Alford was allegedly overcharging for legal fees (since he was using an unlimited amount of tax money and likely thought he wouldn't get caught) and the checks were written by fellow swindlers Steve Riley and Brian Hulbert.

- 5. All of this violates current SC law, according to a recent ruling by the SC Supreme Court, in a case filed by my personal hero Ned Sloan, represented by his hero Lawyer Jim Carpenter that said basically it's illegal to use public funds that are not for the public good, reason ,purpose and intent.
- 6. You all are Chamber members, correct, since you all used general tax funds to join the chamber not your own money, yes? If you deny this, than who is a member? Many of

you attended the Chamber Ball and received gratis tickets by personal invitation from the Chamber thief-in-chief, Bill Miles. You dined at his private table(what an honor) as a "quid pro quo".

Do you deny tax money was used and accepted, and checks were cashed in your names?

So are not all tax payers in Beaufort County, the Town of Bluffton and the Town of Hilton Head all members too? Not just Councils and employees, yes?

- 7. Where is the 2m accounting for the old Welcome Center property sale and attempted robbery to build a new Welcome Center at a cost of \$600 per square ft, reportedly calculated by Bill Miles? And weren't Steve Riley and Tom Peeples, also Greater island Council members, involved when this 2m plus was handed to Miles, Paula Bethea and David Tigges, as well as the Coastal Museum at Honey Horn? What happened to all this theft and misuse of taxpayer monies?
- 8. Is it true a town code enforcement officer assaulted a native islander's wife? And this same town employee approved, then denied, their business zoning?
- 9. Isn't it true the Town fraudulently erected a sign at the foot of the Hilton Head bridge that reads "Hilton Head Town Limit"?

Shouldn't that be removed, and a new sign made that says "Welcome to Jenkins Island"?

Josh Gruber, disgraced former Beaufort County employee, lied by claiming this strip of land is owned by the Town. Hard to believe anything Gruber says, given he is currently under a state ethics investigation, and also secretly and used our tax money with his partner in crime, Steve Riley.

10. Last, if you are all chamber members by the simple fact you used tax money versus your own money to join a private entity, are you not legally required, on behalf of all tax payers, to seek full access to all Chamber CVBB's and DMO's full accounting records, not just ATAX as Council members? Particularly since members are in essence chamber owners, investors and stakeholders and have the same rights as Chamber employees have under the "SC non profit corporation act laws". As chamber members we get to see how ATAX money was misused, stolen and laundered, and how membership dues were used, the SC PRT matching grants, the 1m taken to Canada to develop illegally operated apps and websites, and low the illegal advertising profits were used to pay for lavish spending, 400-1m salaries, world travel, 1.6 million home for Miles, his 500k mountain house in Cashiers NC, golf

entertainment, perks, bonuses, the fraud, embezzlement, pay offs, kick backs, all bank accounts etc.

Lawyer Keaveny, Hulbert and Finger, if it's true you don't have to comply to ATAX FOIA for all hired DMO's in Beaufort County, all General tax use FOIA's, stop the SC unconstitutional illegal misuse of tax funds as well as criminal use, fact you unconstitutionally, illegally and criminally misused 260k plus of general tax funds under state law, fact you and the hired Dmos who are illegally misusing our tax monies, you violated procurement, you were part of the illegal and fraudulent corrupted drafted DMO contract and some have no contracts, fact your hired DMO's are in Violation to 501-c6 non profit tax codes and not paying Irs Ubit taxes on the sale of millions of advertising on illegally operated Atax funded DMO websites and apps, that should be owned by the County and towns, not the private Chambers Cvbs who you illegally hired in Violation of sc procurement laws? Is it not true you are all liable to pay the Irs Ubit tax violations since you are supposed to control the hired DMO actions and not allow the hired DMO's to break the law?

Add SCprt and SC Terc also refusing my foia as well as Charleston Cvb and Myrtle Beach Chamber. All have refused my membership, even the SC Chamber that lawyer David Tigges now sits on its board, to help further corrupt this chamber with Paula Bethea and Bill Miles. Ted Pitts head of SC chamber called me on my cell and said the board voted to refuse your membership, I said for what reason and he said we don't have to give you a reason and hung the phone in my face.
