A veteran finance manager was named Tuesday as the Beaufort County School District's new chief financial and operations officer.

Tonya Crosby has been with the district for 16 years and previously served as finance services officer. Her responsibilities included preparing a \$215 million annual budget, developing annual financial statements, supervising general accounting functions and training staff in budget preparation.

As chief finance and operations officer, Crosby will direct the budgeting, accounting and reporting of all district funds; take a lead role in long-term financial planning; direct the development of the capital facilities plan; and be responsible for divisions such as technology and food services.

Superintendent Jeff Moss said the district has a "well-deserved and time-tested reputation for efficient business operations and prudent budgeting."

Over the past 17 years, he noted, the district has never had a negative financial finding in any of its annual independent audits and has won numerous awards for excellence in financial reporting. Its bond ratings are Aa1 with Moody's Investors Service and AA with Standard and Poor's.

Crosby, a graduate of Clemson University, is a certified public accountant and government finance officer. She began working for the district in 2001 as an accountant before being promoted to accounting manager in 2002 and finance services officer in 2005.

Crosby replaces Phyllis White, who retired in December.

The district also hired a veteran Aiken County school bus executive as director of transportation.

Maria McClure worked in various positions with Aiken County over 31 years, starting as a bus driver.

After being promoted to transportation secretary and later to transportation supervisor, she was named as executive manager of transportation, a position she held for 13 years. She also performed exams for commercial driver's license applicants.

"I'm excited to begin a new chapter in my transportation career, particularly working in uch a beautiful place and with such welcoming people," McClure said.

McClure will supervise about 175 drivers and staff responsible for transporting more than 11,000 students to or from school on about 190 buses that travel more than 11,000 miles each day.

## DEFINITION of 'Tax Anticipation Note - TAN'

A short-term debt security issued by a state or local government to finance an immediate project that will be repaid with future tax collections. State and local governments use tax anticipation notes to borrow money, typically for one year or less and at a low interest rate, in order to finance a capital expenditure such as the construction of a road or school. The government then uses the following year's tax revenue to repay the TANs.

Tax anticipation note financing helps governments smooth out the ups and downs in their revenue cycles, if the timing of their receipts does not match the timing of their expenditures. TANs are one of several types of anticipation note that state and local governments can use; others include revenue anticipation notes, tax and revenue anticipation notes and bond anticipation notes. Tax anticipation notes are a type of municipal bond, so the interest earned from TANs is generally tax exempt for investors.
