



**RESOLUTION NUMBER 933  
OF THE RICHLAND SCHOOL DISTRICT  
INTERLOCAL AGREEMENTS**

WHEREAS, school districts in the State of Washington are authorized by RCW 28A.320 and RCW 39.34, to enter into Cooperatives, Purchasing Alliances, and Interlocal Agreements for the purchase of various equipment, supplies, and services;

WHEREAS, the Richland School District No. 400 desires to reduce costs in purchasing various equipment, supplies, and services for use in the school district through competitively bid contracts; and





WHEREAS, the Richland School District recognizes that membership in certain Cooperatives, Purchasing Alliances, and Interlocal Agreements will permit the District to access competitively solicited purchasing contracts offering a broad range of products and services; and

THEREFORE, BE IT RESOLVED, that the Board of Directors of the Richland School District No. 400, Benton County, Washington, authorizes the Superintendent or Designee to register the Richland School District as a member of the following Cooperatives, Purchasing Alliances, and Interlocal Agreements:
