All students must be registered at Jericho Central Registration located at the High School in order for the district to provide services such as transportation and textbooks. Please call (516) 203-3600 Ext 3244 for further information.

To the Parents of Private and Parochial School Students:

Residents of the Jericho School District, whose children will be attending a private or parochial school during the 2021/2022 school year must submit a transportation application to the Transportation Department **on or before April 1, 2021**. Failure to submit the application by April 1st could jeopardize your ability to qualify for transportation.

Transportation is not provided for schools over 15 miles from your residence. Late buses are provided if there are five or more students who will ride the bus on a daily basis. It is understood that transportation will **not** be provided on the following days: Columbus Day, Veteran's Day, Thanksgiving Day and day after, Christmas Day, New Year's Day, Martin Luther King Day, President's Day, Memorial Day and Labor Day. "In addition, each general election day and any day appointed by the president of the United States or by the governor of New York State may be declared holidays." **There will be no bus service for orientation.**

If Jericho Schools are closed due to inclement weather, there will be no transportation for any schools. If the district is operating with a delayed opening, all schools will be transported on a delayed schedule. School closing information can be found on our website at www.jerichoschools.org. Please refer to the district calendar for further information.

All new residents and students who move within the Jericho School District must prove residency. Students who transfer to another school must contact the Jericho Transportation Department. You can reach us at (516) 203-3600 Ext. 3244 if you have any questions concerning the registration procedure.

A separate transportation application must be submitted each year for each child. Please use our application as we will not accept the private/parochial school's application. Please notify our office with any address change, new home or cell numbers or if transportation is no longer needed. Eligible children **must** be five years old no later than December 1, 2020. Public school age requirements govern all transportation eligibility.

All information on the enclosed application must be filled in and returned to the Transportation Department at Jericho Schools, 99 Old Cedar Swamp Rd., Jericho, NY 11753, on or before April 1, 2021.
