



Tuition Information 2022-2023

- One Catholic student in family at Bishop John J. Snyder High School: **\$9,774**
- Two Catholic students in family at Bishop John J. Snyder High School: **\$17,977**
- Three or more Catholic students in family at Bishop John J. Snyder High School: **\$24,701**
- Non-Catholic student: **\$12,414**

Registration Fee: \$400 per family

This fee is due at the time of registration and is non-refundable.

General Fee: \$1,000 per student

The General Fee is non-refundable.

If not paid by April 20th, the general fee will be added to your FACTS payments.

The *General Fee* includes materials (unless otherwise indicated in the course catalog), catastrophic student insurance, School Counseling services, and standardized testing. It does **not** include Saturday School, uniforms (daily and/or PE) field trips, books, yearbooks, or parking passes.

Senior Graduation Fee \$100

The *Senior Graduation Fee* includes cap and gown, Senior Awards Ceremony, graduation venue rental and senior awards. It does not include graduation announcements or other graduation regalia. This fee is non-refundable.

FACTS Management Company

Bishop John J. Snyder High School contracts with FACTS to electronically process tuition payments. Through FACTS E-Cashier, you can arrange for monthly or semi-annual automatic bank payments from your checking or savings account. Payment date options are the 5th or 20th of the month.

All families must set up a FACTS account at the time of enrollment, unless tuition and fees are paid in full by May 1st. You will be directed to the FACTS site during the Online Enrollment process. If you have any questions, please call Edna Corrigan at (904) 908-8960.

Payment Options

Option #1

May 1, 2022 Annual tuition due to Bishop Snyder High School main office

Option #2

May 1, 2022 Semi-annual tuition FACTS withdrawal #1
A one-time **\$10 FACTS fee** will be assessed and collected by FACTS with the first withdrawal.

Nov. 1, 2022 Semi-annual tuition FACTS withdrawal #2;

Option #3

May 2022 – Feb. 2023 Tuition payments 1-10 due monthly on the 5th or the 20th
A one-time **\$41 FACTS fee** will be assessed and collected by FACTS with the first withdrawal.

Applying for Tuition Assistance

Bishop John J. Snyder High School contracts with the FACTS Management Company for tuition assistance applications. The open application process begins in February.

Applications for assistance can be accessed by going to www.factsmgt.com (you will need to provide tax return documents and recent W2 documents).

Tuition assistance is limited and applications will not be considered until the student's enrollment is completed (including payment of the registration fee and FACTS Payment Plan setup.)

Scholarships

Bishop John J. Snyder High School accepts the following state scholarships. These scholarships help reduce the cost of tuition but do not cover the entire tuition balance or the cost of books and uniforms.

The balance of the tuition is the responsibility of the parent.

The McKay Scholarship and Gardiner Scholarships are funded through the Office of Independent Education & Parental Choice, providing Florida students with special needs (i.e. ADD/ADHD or a diagnosed learning disorder) the opportunity to attend a participating private school. The student must be enrolled in a public school to apply for the McKay Scholarship. For more information, please go to www.floridaschoolchoice.org.

Step Up For Students/Gardiner Scholarship provides Corporate Tax Credit Scholarships to students in K-12 who meet certain financial criteria. Students enrolled in a public or private/Catholic school may apply for the scholarship. For more information, go to www.stepupforstudents.org.
