



OPTIONAL CHROMEBOOK INSURANCE

The Chromebook will be covered in the event of:

Accidental Damage
(drops/spills/broken screen or LCD)
Theft (with police report)
Fire
Flood/Natural Disasters

What is not covered?

- Lost/unable to locate
- Intentional damage or damage due to failure to follow Chromebook policy

WITHOUT INSURANCE:

- Stolen Chromebook: up to \$195
- Damaged Chromebook – repairable: up to \$100
- Damaged Chromebook – beyond repair: up to \$195

Liability Chromebook- Student issued

Students and parent(s)/guardian(s) are responsible for the care, maintenance and safe-keeping of the Chromebook and its accessories while the device is signed out to that student. While the Muncie Community Schools (MCS) is issuing the Chromebook for student use at no cost, a financial assessment will be levied against the student and that student's parent(s)/guardian(s) based on any damage or loss of the device due to misuse or neglect. When so directed by MCS, the Chromebook, along with the protective cover and charging equipment, must be returned to MCS with only normal wear and without alterations. Repairable damage will be assessed, at cost, to the student and the responsible parent(s)/guardian(s). Unrepairable damage or complete loss (including theft) of Chromebook will result in a fee of up to \$207 assessed to the student and the parent(s)/guardian(s). Parent(s)/guardian(s) may voluntarily opt to purchase no deductible insurance from MCS to avoid some of these charges. Financial responsibility for the Chromebook is NOT waived for those students who have qualified for free-reduced lunch and free textbooks.

The annual premium for no deductible insurance coverage is \$36, payable to MCS at the time the Chromebook is issued to the student. Please see the opposite side of this page for details on what is and is not covered.

In order to file a claim, the damaged Chromebook must be presented to MCS or, in the case of theft, a copy of the police report must be presented.

A replacement Chromebook will be provided to the student upon claim settlement (beneficiary is MCS) if insured, or if no insurance was purchased, upon payment of the assessed fee or signature on Fee Obligation form.

Failure to repay any cost or charge assessed hereunder to MCS will result in referral of the account to a collection agency.
