

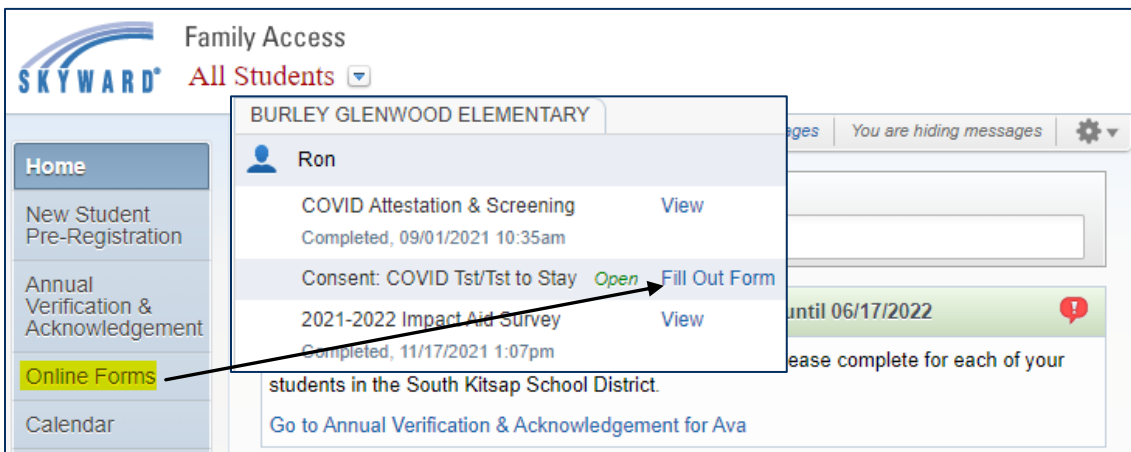

Tip: Please note that secondary households do NOT have access to this survey via Family Access. Secondary households may request a hard copy of this form from their student's school or from the testing site.

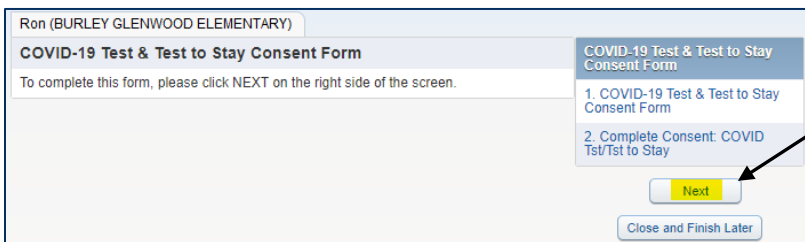
Start by logging in to Skyward Family Access: <http://family.southkitsap.wa-k12.net>. If you're using a smartphone, you must login through your web browser.

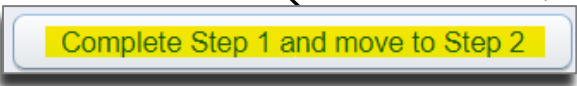
