I. STATEMENT OF PURPOSE

The **HUBERT R. HUDSON ELEMENTARY** provides support for online Instructional Models: Hybrid, Traditional, and At Home Learning and the school is committed to providing quality education to every student in the district. III. ANNUAL TITLE I-A CAMPUS PARENT MEETINGS
