- 10. Section 2-578, item 10, allows up to a ten (10) percent differential in favor of resident Bidders for all purchases and contracts except construction and/or capital improvements. Any city-based bidder, which has submitted a bid, shall be awarded the bid provided that such city-based bidder agrees to accept the award of the bid at the amount of the low bid. **SCOPE:** This bid covers the requirements of the City Public Works Department, Utilities Division, for various chemicals/gases specified herein for the period July 1, 2015 to June 30, 2016.

**LAWS:** All deliveries hereunder shall comply in every respect with all applicable laws of the Federal Government and/or the State of Connecticut.

**TAXES:** Purchases made by the City of New Britain are exempt from the payment of Federal Excise Tax and Transportation Tax and the Conn. State and Use Tax, and such taxes must not be included in the bid price.

**BID PRICES:** Prices shall be net including all transportation charges fully prepaid by the Contractor F.O.B. destination. No additional charges will be allowed for packing or packages. No demurrage charges will be paid by the City.

**QUANTITITES:** The proposed contract shall cover the actual requirements of the Utilities Division. It is understood and agreed that the contract shall cover the quantities actually ordered by the Utilities Division. No guarantee is made, express or implied as to the actual quantities to be ordered.

**EXCEPTION:** The City reserves the right to contract separately for unusual large quantity purchases of single items and emergency purchases.

**DELIVERIES:** Deliveries shall be made at such time and in such quantities as ordered in strict accordance with the instructions listed on the purchase order. Bidders must have copies of their NSF certification attached to their bid packages. If no NSF approval exists for a specific chemical, a trade or government agency certification may be accepted.

All chemical vendors shall be responsible for all clean-ups and cost of said clean-ups for any spills of chemicals that are released during the delivery of the contracted product. This shall include minor leaks at the appropriate fill stations.

#### **DETAILED SPECIFICATIONS**

#### 1. ACTIVATED CARBON SPECIAL:

Quality – Special activated carbon prescribed in the treatment of drinking water – AWWA Standard B 600 shall be of low density. Packed into 2 bags of 50 pounds to each securely sealed carton. A certificate of quality shall be provided with every delivery. Approximate yearly total 10,000 lbs.

#### 2. CHEMICAL HYDRATED LIME (bulk form):

Quality – The Hydrated lime shall conform to AWWA Standard B202 (latest edition) and NSF standard 60. The material shall be in powdered form, shall contain no lumps, and shall be free from any foreign matter. The material shall be graded such that it does not impair the filter plants feed system or increase turbidity levels due to the products insolubility. The supplier shall provide all appropriate equipment needed to for the safe and efficient delivery of the product. The product shall be delivered to a 48-foot high storage silo through a feed located at the base of the silo. A certificate of quality shall be provided with every delivery. Approximate delivery rate of 45,000 lbs. per delivery. Approximate total for year 450,000 lbs.

#### 3. CALCIUM HYPOCHLORITE:

AWWA Standard B300, 65% granular packed in drums less than 100 pounds. Approximate total for year 1,000 lbs.

#### 4. COPPER SULPHATE:

AWWA Standard, B 602, **large crystals only Delivery rate of 10,000 lbs.** Approximate total for year 50,000 lbs.

#### 5. HYDRO FLUOSILICIC ACID LIOUID:

A biannual report of these parameters shall be provided to the Utilities Division at no additional cost. Additionally the Utilities Division requires that the vendor provide a certificate of quality with all deliveries. The following information must be included on the certificate:
