Update to Communication Protocols about Positive COVID Cases in Our Schools

In an effort to be more efficient in our communications, beginning next week, the district will be modifying its notification about positive COVID cases. We will no longer be sending out schoolwide emails <u>each day</u> there is a positive case at one of our schools. Schoolwide numbers will continue to be maintained on the district dashboard, which is <u>updated weekly in the district newsletter</u>. **All close contacts will continue to be notified in real time as they have been since the start of the pandemic.**

Here is our weekly snapshot of school-related cases. Close contacts are being communicated in 2 columns, whereas the Maine CDC exempts people from school quarantine if they have classroom only contact (since we are universally masking), are fully vaccinated, or actively participating in pooled testing.

COVID-19 Vaccination Clinics-Round 2

The 2nd round of vaccine clinics for K-6 students are happening next week! Each building has shared logistics for parents who choose to be present for their child's second vaccination. Once fully vaccinated (14 days after the 2nd dose is administered), students will not be subject to any kind of quarantine, either at school or in the community.

Pooled Testing at the High School Being Finalized

Pooled testing is well in place at all of our K-8 schools. At this time, we are closing the loop with the final school, Scarborough High School, with a **target date for beginning the week of December 13.** In case you have not yet signed up, here is a link to the consent form and the access code that you will need:

This sign-up process should take no more than 5 minutes for you to complete using a computer or a smartphone. We also have paper copies available through the school if you would prefer that, as well as consents available in multiple languages. Please note that if your child is already 18, they should fill out their own form using the link for adults. IMPORTANT NOTE: Lists for weekly pooled testing are generated the Thursday preceding the the pool. So, for example, if you are interested in your child pool testing on the week of Dec 13, you must have them signed up by Thursday, Dec. 9.

NWEA MAP Reports Heading Home This Fall

The individual student results of the fall **NWEA MAP Growth Tests** will be going home to families this fall. They will include a Reading, Language Usage and Mathematics report. Middle school and high school reports will be going home between mid-November and mid-December. Families of students in grades 3-5 will receive their reports in mid December with their report cards. To learn more about these reports, here is a link to a Sample Family Report.

We are sharing the NWEA reports with you now in our efforts to provide you with the current information we have regarding your child's performance on this assessment. As students will be required to take these assessments again in the spring, we will be sending these reports home again by the end of the school year.

The data is very important to us as it will assist us in making improvements to our curriculum and instruction. We track and study group data to inform shifts in curriculum and we look at classroom.

and individual data to plan for instruction. The spring data will be used to gauge and celebrate growth.

Our primary purpose for these assessments is not to give your child a score or grade but to determine how to best support their learning and their growth. They are not placement tests. They are tools, along with classroom data, to help your child continue their learning at an appropriate level of challenge and celebrate their growth. NWEA is an adaptive assessment that adjusts questions to identify your child's areas of instructional readiness.

Return to School Requirements for International Travel

For those of you traveling outside of the United States, please follow the state mandate as listed below, per the Maine Center for Disease Control and Prevention requirements:

For all people who are **NOT FULLY VACCINATED** and arrive in Maine within 7 days of entering the United States:

- Quarantine for 7 days from arrival in the US <u>AND</u> get a COVID-19 molecular or antigen test 3-5 days after arrival in the US.
 - If the COVID-19 test is positive, isolate.
 - Even if the COVID-19 test is negative, complete the 7-day guarantine after travel.
 - If individuals arriving from international travel do not get a COVID-19 test after their arrival, they should quarantine for 10 days after their arrival in the US.
- Avoid being around anyone who is at increased risk of severe COVID-19 illness for 14 days following arrival in the US, regardless of COVID-19 test results.

For people who ARE FULLY VACCINATED (at least 14 days past their final COVID-19 dose) who arrive in Maine:

- Quarantine is not required unless you are experiencing symptoms.
- Testing is recommended 3-5 days after arrival in the US.
 - If the COVID-19 test is positive, isolate.



2021-2022 Breakfast & Lunch Ordering Protocols

As a general reminder, all breakfast and lunch meals for all students in Scarborough Schools are free for this school year 2021-2022. All existing students whose parents have an account will be able to order breakfast and lunch using the same procedure as last year, from the Nutrislice app on a device or at https://www.scarboroughschools.org/ (at the top of the page click "Quick links", then go to School Lunch for all meal menus).

All Kindergarten and new students to the district will have to make a Nutrislice account through the Nutrislice app or through https://scarboroughschools.nutrislice.com/menu/create-account

before they can order breakfast and lunch. Parents will need the child's ID# before they can start the registration process.

For breakfast meals in all of our schools, you can order online on the same day before 6:30 AM, while for lunch meals, you can order online on the same day before 7:30 AM. You can order meals for the day, or set up a weekly or monthly plan for meals to be provided to your children. The menus for all meals for a new month will be posted on the school's website and on the Nutrislice app the last Monday at the end of the previous month.

Each school has created their own system for their lunch disbursement. They are continually reviewing the process and making modifications as needed. Please be patient with our school staff as they work towards improving and refining their daily lunch routines.
