Commodity/Service Being Requested: Vehicles

Type of Solicitation: Request for Proposals (RFP) – Wayne RESA, in partnership with the Michigan Association of Counties (MAC) CoPro+ Program, is competitively bidding and awarding a Master Agreement to a manufacturer or dealer for the purchase and/or lease of vehicles statewide. This contract will enable schools (public, private/parochial, and charter/public school academy), non-profit organizations, and public municipalities to purchase and/or lease Vehicles from a supplier(s).

This contract will enable public municipalities, non-profit organizations, and schools to “piggyback” and purchase on an “as needed” basis from the supplier(s). **Contractors serving a specific area(s) of the State will still be considered for selection. These contractors will need to list those areas of the state that they provide vehicles when submitting their proposals.**

Type of Resulting Contract: Statewide Cooperative Contract – As a result of this RFP, Wayne RESA will work with the Michigan Association of Counties CoPro+ program to market and extend the resulting contract to other public municipalities, non-profit organizations and schools statewide in having access to a pool of pre-qualified suppliers available for Vehicles.

Resulting Contract Term: Three (3) years with two (2) one-year renewal options.

SECTION 1.0 – BIDDER RESPONSES TO SCOPE OF WORK AND PRICING

1.1 Minimum Mandatory Requirements

All proposals will be reviewed for compliance with the mandatory requirements. Proposals deemed non-responsive will be eliminated from further consideration.

Interested and qualified proposers that can demonstrate their ability to successfully provide the goods and services requested under this RFP are invited to submit proposal(s), provided they meet the following requirements:

1. Proposer must have three (3) years' experience, within the last five (5) years, providing a range of Vehicles being requested by Wayne RESA as described herein.
2. Provide pricing to Wayne RESA/MAC cooperative members on a wide range of Vehicles.
3. Knowledge of product lines and persons able to assist entities on identifying the correct vehicle for the need.
4. If awarded, proposer will be required to present all product information in electronic catalogs.

Proposer Response:

Proposer will enter responses in the “Proposer Response” text boxes provided. There is no requirement or limitation on the amount of words used for responses.

1.2 Product and Service Categories

It is the intention of Wayne RESA to competitively award vendor(s) for a wide range of vehicles. Awarded vendor(s) shall provide products and perform covered services under the terms of this agreement.

Wayne RESA is seeking a contractor(s) that has the depth, breadth and quality of resources necessary to provide some or all of the following vehicle types under this solicitation:

1. Box trucks of various sizes – refrigerated and non-refrigerated
2. Cargo vans
3. Pick-Up trucks
4. Buses
5. Passenger vans
6. Passenger cars
7. Pursuit vehicles
8. Emergency Vehicles
9. Other

Please list all types of vehicles your company can provide in your proposal.

1.3 Scope of Services

It is the intention of Wayne RESA to order vehicles with specification assistance from the awarded vendor(s). Vendor will price the vehicle as per the pricing Methodology described in their proposal with options required in the specifications. Vehicles will be delivered as ordered to the ordering entity. Each ordering entity will be responsible for payment of vehicles ordered.

1.3.1 Vehicles

Proposers are to provide multiple options for purchase or lease. In your proposal, please provide and describe all purchase and leasing options available.

1.3.2 Equipment and Services

- a. Condition of Equipment: All equipment shall be up to date. This shall be interpreted as the latest models available at the execution of the signed contract.
- b. Maintenance Agreements and/or programs: For participating agencies making a purchase or those entering into a lease agreement, Contractor shall provide maintenance agreement plans. These plans shall include fee structures for equipment maintenance, repair, and replacement. Contractor shall provide information on how equipment problems will be handled and locations available to provide service. In the event that a Contractor chooses to subcontract its services during the term of the contract, service calls made by participating agency staff should be handled through the Contractor directly.
- c. Please describe any maintenance software or programs available to ordering entities.
- d. Vehicle Malfunctions: For participating agencies entering into a lease agreement, Contractor shall provide a written policy regarding the handling of malfunctioning equipment to the agency. In the event that a Contractor chooses to subcontract its services during the term of the contract, repairs made by participating agency staff should be handled through the Contractor directly.
- e. Please describe any fueling programs offered or available.
- f. Branding: Proposers are encouraged to offer vehicles that accommodate participating agencies branding opportunities. Placement of logos and/or slogans or vehicle wraps are examples of branding possibilities.

1.3.3 Statewide Cooperative Contract

Wayne Resa is working with the Michigan Association of Counties CoPro+ program on this bid solicitation. If your bid meets the minimum qualifications, is responsive and responsible and offers competitive pricing you may be considered and approached to extend a term agreement and pricing to other public entities within the county, the region, and the state, in accordance with Michigan Compiled Laws 124.504. This process is called "piggybacking"; it offers tremendous value to public ordering entities regarding the cost and time to manage an end-to-end purchasing event. This process also offers exceptional value to selected vendors in terms of their company's resources and time to respond to multiple solicitations from various public entities who have a similar need for their products or services.

All pricing submitted to Wayne RESA and its participating entities shall include a 2.0% administrative fee to be remitted to CoPro+ by the contractor on a quarterly basis. Administrative fees will be paid against actual sales volume for each quarter. It is the contractor's responsibility to keep all pricing up to date and on file

All pricing submitted to WAYNE RESA shall include 2.0% administrative/remittance fee to be remitted to CoPro+ by the awarded vendor. It is the awarded vendor's responsibility to keep all product listings up to date and on file with WAYNE RESA/CoPro+.

Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion

The prospective contractor certifies, by submission of this proposal, that neither it nor its principals are presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded for from participating in this transaction by any Federal department of agency. CERTIFICATIONS/DISCLOSURE REQUIREMENTS RELATED TO LOBBYING

Section 319 of Public Law 101-121 (31 U.S.C.), signed into law on October 23, 1989, and imposes new prohibitions and requirements for disclosure and certification related to lobbying on recipients of Federal contracts, grants, cooperative agreements, and loans. Certain provisions of the law also apply to Federal commitments for loan guarantees and insurance; however, it provides exemptions for Indian tribes and tribal organizations.

Effective December 23, 1989, current and prospective recipients (and their subtier contractors and/or subgrantees) will be prohibited from using Federal funds, other than profits from a Federal contract, for lobbying Congress and any Federal agency in connection with the award of a particular contract, grant, cooperative agreement, or loan. If a satisfactory Master Agreement cannot be negotiated, Wayne RESA may, at its sole discretion, begin negotiations with the next qualified proposer who submitted a proposal. It is anticipated that pre-qualified contract awards will be made to multiple vendors.

1. Evaluation Factors for Statement of Work (Section 1) – 30 points
2. Company Profile (Section 2.1) – 10 points
3. References (Section 2.2) – 10 points
4. Vehicles and Programs available - 20
4. Pricing (Section 1.10 and Attachment A) – 30 points

3.10 Wayne RESA Option to Reject Proposals

Wayne RESA may, in its sole and absolute discretion, reject any or all proposals submitted in response to this RFP. Wayne RESA shall not be liable for any costs incurred by the Proposer in connection with the preparation and submission of any proposal. Wayne RESA reserves the right to waive inconsequential disparities in a submitted proposal.

3.11 Freedom of Information Act

This contract and all information submitted to Wayne RESA by the Contractor and Proposers is subject to the Michigan Freedom of Information Act (FOIA), 1976 PA 442, MCL 15.231, et seq.

Wayne RESA shall not, in any way, be liable or responsible for the disclosure of any such record or any parts thereof, if disclosure is required or permitted under the Michigan Freedom of Information Act or otherwise by law. The Proposer(s) must specifically label only those provisions of the proposal, which are actually trade secrets, confidential, or proprietary in nature. A blanket statement of confidentiality or the marking of each page of the proposal as "Trade Secret", "Confidential", or "Proprietary" shall not be permitted. Any such designation will be disregarded.

By submitting a response to this RFQu, the Proposer shall be deemed to have agreed to indemnify and hold harmless Wayne RESA for any liability arising from or in connection with Wayne RESA's failure to disclose, in response to a request under the Michigan Freedom of Information Act, any portion or portions of the Proposer's response to this RFQu which have been marked "Trade Secret," "Confidential," or "Proprietary."

3.13 Final Agreement Award Determination

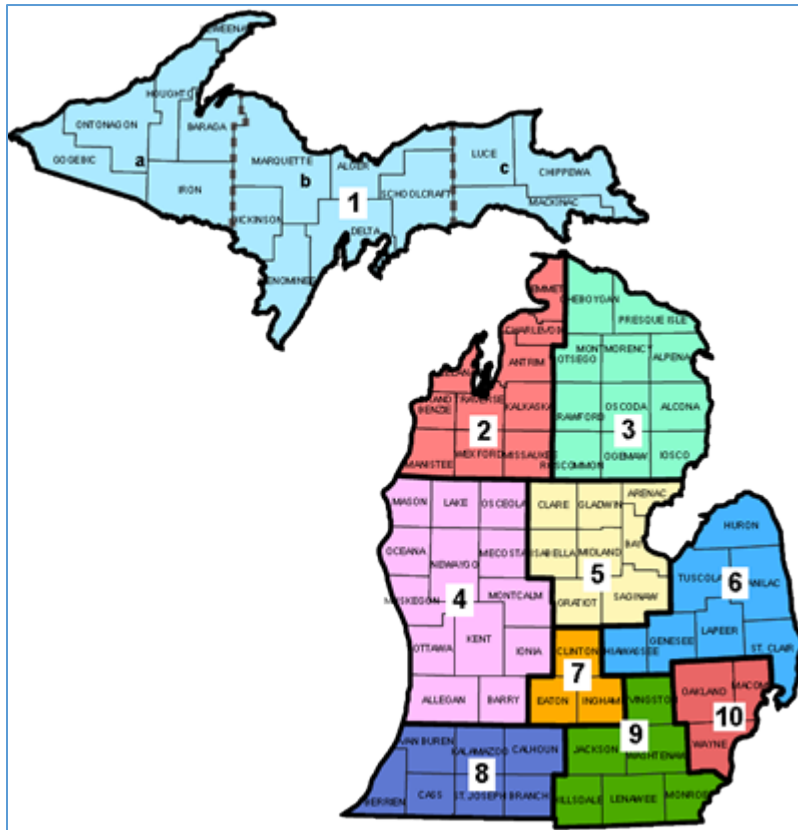
