<u>Student Achievement Liaison</u> – Dr. Dinopoulos reported on the remote learning impact on student learning – Is there a lag? The district is developing a plan to develop strategies using MAP system. Juniors are getting ready to take ACT. As we collect more data, we will be proactive in identifying which areas need addressed. Overall, we continue to maintain consistent growth in the midst of COVID19. A third data point will be added after spring testing.
