<u>Approval to Assign David Janofa as Special Assistant to the Superintendent – Resolution</u> #2020-171

Mr. Polis moved and Mr. Warren seconded with all members present voting aye to approve the resolution Assigning David Janofa as Special Assistant to the Superintendent. Motion passed 5-0.

Whereas, the Board has accepted the resignation of Superintendent David Janofa, effective February 1, 2021, for purposes of retirement; and

Whereas, Mr. Janofa has indicated his desire to assist the District with the leadership transition precipitated by his forthcoming retirement date; and

Whereas, Mr. Janofa has offered to facilitate the seamless transition by accepting an assignment to an administrative position supportive to the interim Superintendent;

Now, therefore, be it resolved, that the Board assigns David Janofa to the position of Special Assistant to the Superintendent for the period beginning November 1, 2020 and ending on January 31, 2021, and Mr. Janofa agrees to accept his reassignment to said position under the terms and conditions of his current contract of employment, which shall include the ability to work remotely, and shall otherwise remain in full force and effect until his retirement on February 1, 2021.

Approval to Employ Interim Superintendent – Resolution #2020-172

Now, therefore, be it resolved, that the Board hereby employs Dr. Edwin Holland, Interim Superintendent, effective November 1, 2020, for the period ending July 31, 2021, and authorizes and directs the Board President and Treasurer to execute a contract of employment with Dr. Edwin Holland, Interim Superintendent on behalf of the Board, on such terms and conditions as have been agreed to by the parties.
