Welcome back to all of our contractors, drivers and assistants! I trust that everyone has enjoyed their extra week of summer thanks to our first post- Labor Day start of school in many years.

School starts this year on Tuesday, September 5, 2017, and is scheduled to end on Thursday, June 14, 2018. There are six snow days built into this year's calendar, so if we're lucky enough to get through the winter without using any snow days, school will end on Wednesday, June 6! There are also six two-hour and forty-five minute early dismissal days in this year's school calendar with the first one scheduled for Friday, October 6, 2017. A copy of the school calendar can be found later in this newsletter and in your *Contractor/Bus Driver Handbook*.

Four elementary schools are starting and ending 15 minutes earlier from last school year. Those schools are: Ebb Valley Elementary, Elmer Wolfe Elementary, Mt. Airy Elementary and Parr's Ridge Elementary. These four schools will have a 9:15 a.m. – 3:45 p.m. schedule for the 2017-2018 school year. Please be sure to review the list of your school times and bus arrival windows located in your *Contractor/Bus Driver Handbook*.

As compared to the start of last school year when we had significant changes to bus routes resulting from school closures, I am pleased to report that only minor changes were necessary this year, impacting a relatively small number of regular education bus routes. As is always the case, you may expect that there will be many changes to special education bus routes related to student and program changes. We will start out this year with a total of 261 route buses, two fewer than the 2016-2017 school year. There will be 190 regular education routes, 54 in-county special needs routes and 17 out-of-county routes to start the school year.

Please take the necessary time to thoroughly review your bus routes prior to the start of school and give yourself a little extra time during the first few days, as the motoring public will be adjusting to buses being on the road after not seeing them since June. As always, keep your defensive driving practices at your ready use and be prepared for the unexpected. Please remember that you are the first person representing the Carroll County Public Schools that students and parents will see on the first day of school.

Thank you for your dedication and commitment to providing safe and reliable transportation for our students.

*Emergency Closing Days

If any of the six (6) emergency closing days are not used, the last day for student and staff are as listed below: One (1) day not used — Last Student Day — June 13th, Last Staff Day - June 14th. Two (2) days not used — Last Student Day — June 12th, Last Staff Day — June 13th.

Three (3) days not used — Last Student Day — June 12th, Last Staff Day — June 13th, Four (4) days not used — Last Student Day — June 8th, Last Staff Day — June 11th, Five (5) days not used — Last Student Day — June 8th, Last Staff Day — June 8th,

Six (6) days not used - Last Student Day - June 6th, Last Staff Day - June 7th.

In the event that the school year is shortened due to unused emergency closing days, the last student day will be a two-hour and forty-five minutes early dismissal. The one-day immediately following the last student day will serve as a professional day for teachers.

If further emergency days are required, the following schedule will be implemented: One (1) day needed - The last student day will be June 15, 2018.

If additional emergency days are needed beyond June 15, the Board will request a waiver from the requirement that the school year end no later than June 15, allowing make-up days to be scheduled the following week.

DRIVER INSTRUCTORS' CORNER

CHANGE OF ADDRESS

Commercial drivers must appear in person at the Motor Vehicle Administration (MVA) to obtain a corrected license. Drivers have 30 days to make the change. The fee is \$20. The driver/contractor must submit a copy of the new license to Dena Hozik, Driver Instructor Lead at dmhozik@carrollk12.org and Dena will change the driver's information in our data files.

ID BADGE REPLACEMENT

To obtain a replacement ID badge, drivers must go through their contractor – who will contact Dena Hozik to get the process going.

DOT PHYSICALS

All physicals are to be submitted to MVA and Dena Hozik prior to the physical's expiration date. Drivers that do not comply with this requirement will have their license suspended by the MVA.

Students will enter your bus in a variety of ways: happy, excited, scared, angry, unsure, active, aggressive, needy, and a host of other verbs and adjectives. Thank you for being professional, understanding, fair, caring, in control, and patient in order to support a positive bus ride.

QUESTION:

What are some good techniques that drivers and assistants use daily that promote a safe and positive bus ride?

ANSWERS:

- Greeting each student by name every morning and afternoon.
- Remembering each day is a new day.
- Always doing a walk through.
- Seating the bus assistant in such a position as to be able to quickly reach any disturbance. (Best practice is in the middle of the bus.)
- Remembering the reasons we are transporting these students.
- Speaking courteously and professionally at all times.
- The driver and assistant working together as a team.
- Making sure all students, equipment and wheelchairs are secure before pulling away.

HOW TO PREVENT PROBLEM BEHAVIOR ON YOUR SCHOOL BUS

Driving a school bus is a challenging job. You are given the responsibility of safely transporting students of all ages to and from school. You have an obligation to drive safely and attentively in all kinds of traffic and weather conditions. But you also have the duty to supervise the activities of a bus full of students—and to do it all while 😓 keeping your eyes on the road.

Managing the behavior of the students on your bus is probably the toughest part of your job. Here are some strategies that will help you prevent difficult behavior from happening in the first place:

★ Get to know your students.

★ Learn your students' names. Smile and greet them by name each time they get on the bus. Get to know your students.

Be a positive role model.

Be friendly and polite. Say "please" and "thank you." Show your riders the behavior that you would like to see from them. Compliment them when they are behaving well.

Respect students' personal space.

Students have little personal space on a school bus. Be sure that you don't crowd them any more than is necessary. If you must approach a student, remain at least one leg-length away.

Be aware of body language.

Body language includes posture, movement, gestures, and facial expressions. As students board the bus, watch for signs that a student might be anxious or upset. Also, be aware of your own body language. Try not to do things that may appear threatening to the student, such as scowling, putting your hands on your hips, or shaking your finger in a student's face.

Establish rules.

Keep your rules short and simple. If you have too many rules, students won't remember them. Four or five is usually enough. Try to state your rules in a positive way. For example, "Keep your hands to yourself" is more positive than "Don't hit!" Give a written copy of your rules to all riders, and post them on the bus, too.

Set limits when rules are broken.

- When a student breaks a rule, tell the student what rule has been broken and why it is important. Then, set limits. Setting limits means that you provide the student with choices and with the consequences of those choices. Stress the choice you prefer the student to make.
- ★ For example, you might say, "Heather, please sit down on the seat. It could be dangerous if I have to stop the bus quickly."

★ Remain calm.

Even when students are belligerent or insulting, don't allow them to push your buttons. If you lose control, you will probably make the situation worse.

Dealing with students' behavior on your bus is not an easy job. Having a plan to deal with difficult behavior will help you keep control, maintain a positive attitude, and keep everyone on your bus safe.

WALK A MILE IN THEIR SHOES

Our Summer In-Service was highlighted by guest speaker, Ms. Kyla Liggett Creel. Her presentation focused on a case study based on the life of one child's experience as a foster child. The lessons from the presentation were powerful and moving. Hopefully, we all gained insight into the difficulties that life can pose for children in foster care,

and for that matter, homeless children. Although we certainly cannot change the circumstances of these children's lives, maybe our greater understanding can allow us to be more patient with them as we strive to be a positive influence in their lives.

Beyond foster care, I think the In-Service presentation carried an even greater message; many children and families that appear stable, safe and loving, have their own struggles that we know nothing about. Parents of special needs children, whether the special needs condition be physical or emotional, have incredible struggles just to live everyday life. As drivers, although you deal with some extremely difficult children and situations, those situations occur over the course of the length of a bus ride. For the parents of some of these special needs children, the struggles are all day, every day.

For the parents and children in these circumstances, life can be really tough. Just like with the foster child, a little patience and understanding is required for these children. We don't live these families' lives, so we cannot know what stresses and struggles they are undergoing. Maybe in the next year, our mindset should be, "I need to walk a mile in their shoes," and be a little more understanding and tolerant.

INCLEMENT WEATHER POLICY FOR OUT OF COUNTY SCHOOLS

Questions often arise about our policy for transporting students out of county during weather related scheduling changes.



- 1. First, Carroll County buses will always follow a weather-related schedule change for Carroll County Public Schools.
- 2. However, if a CCPS bus is traveling through a county, or the school they are traveling to, has a worse weather-related schedule change than Carroll County, our out of county bus will adhere to that schedule change.

For example, if all surrounding counties are open and Carroll County is delayed, dismissing early or closed, CCPS out of county buses will follow the Carroll County schedule. If Carroll County were to open on time, but a surrounding county is delayed, closed or dismissing early, CCPS out of county buses traveling through or to a school in that county would adhere to the schedule of the surrounding county. Again, the out-of-county buses adhere to the most severe schedule change of any surrounding county they are traveling through or that is their ultimate destination.

We always attempt to notify our out-of-county contractors as soon as we are aware of any early morning schedule changes. Please monitor local media for surrounding counties' inclement weather-related schedule changes.

CARROLL COUNTY ACCIDENT STATISTICS 2016-2017 SCHOOL YEAR

Carroll County School bus drivers were involved in **85** accidents for the school year 2016-2017; **58** of these accidents were determined to be preventable. Of the **85** accidents, **16** involved major damage or personal injury, **10** of the majors were determined to be preventable. The breakdown for the school year as far as preventability is as follows:

ACCIDENT REVIEW

The Accident Review Team meets regularly to determine the preventability of school bus accidents. The determination of preventable does not mean that the school bus driver was primarily or legally responsible for the accident; it means that the driver did not do everything that reasonably could have been done to avoid the accident. In other words, he or she was not a **defensive driver**. A **defensive driver** is one who commits no driving errors and makes allowances for the lack of skill of improper driving practices of other drivers. A **defensive driver** adjusts his or her own driving to compensate for unusual weather, road, and traffic conditions and is not tricked into an accident by the unsafe actions of pedestrians and other drivers. By being alert to accident inducing situations, the **defensive driver** recognizes the need for preventive action in advance and takes the necessary precautions to prevent the accident. It is impossible to describe in detail the many ways a driver might prevent an accident. A school bus driver may not absolve themselves of any defensive driving skills or responsibilities. The Maryland State Department of Education evaluates all major school bus accidents in the state. A report conducted by MSDE makes this point that drivers should remember. The vast majority of accidents happen:

- On clear days
- During daylight hours
- On regular routes
- With buses travelling straight
