June Parent/Guardian Survey of Fall 2020 Plans Background Information

March 20, 2020, Governor Abbott issued an order to close all Texas public schools. April 17, 2020, this order was extended through the end of the 2020 school year. As of June 1, 2020, much is still unknown about what will be the instructional and learning environment in August. In order to gain a better understanding of what parents perceive as current needs, Northwest ISD surveyed parents June 1 to June 9, 2020. Northwest ISD intends to survey parents at least one more time over the summer.

NISD's Curriculum and Instruction department purposefully chose to keep the survey short and free of biasing language that may imply a reason for a selection. The purpose of this first survey was to answer these key questions:

- What are parents' current preferences for their child's instructional setting?
- What percentage of parents would express that their child had a health condition that may prevent the child from returning to campus?
- What percentage of parents would express concern regarding an immediate family member having a health condition that may prevent their child from returning to campus?
- What concerns would parents want to share with Dr. Warren regarding their child returning to campus?

I think the school district handled online courses well given the circumstances. I would hope that preventing the spread of COVID-19 among children will guide your decisions on when and how to best let students return to campus. – Parent of an EHS, 9th grader


The survey was given in 5 languages: English, Spanish, French, Vietnamese, and Arabic. 11044 parents and guardians responded to the survey.

Between 9.3 and 10.8% of all students have a high potential of making a choice to "resume remote learning." 


