CTA ( <i>Appointment of Campaign Treasurer By A Candidate</i> )	By August 22, 2022, 5:00p.m. filing deadline and must be filed prior to donations or expenditures of funds. Can choose modified reporting if expecting to spend less than \$500. A candidate may appoint him/herself Campaign Treasurer.

C/OH ( <i>Candidate/Officeholder Campaign Finance Report – includes Schedules A, B, E, F, G, H, I, K,T</i> )	Due From opposed candidates who did not choose modified (under \$500) reporting
C/OH-FR ( <i>Candidate/Officeholder – Final Report</i> )	Until this final report is filed candidates will remain candidates and are subject to semi-annual financial filing. Those choosing modified reporting must include C/OH- cover sheet, page 1 (checking section 9) with this final report.
