

SCHOOL TAX PROGRAM

Arizona tax law (ARS 43-1089.01) allows taxpayers a tax credit of up to \$200 (or \$400 per married couple) if they contribute to extracurricular activities such as sports, band, yearbook, and fine arts which typically are not fully funded by school districts. These programs depend on fees from students.

The tax credit is available to all State of Arizona tax payers, regardless of whether or not they have children in school. Contributions from businesses are always welcome; however, such contributions cannot be used to obtain a tax credit.

MAKE IT YOUR CHOICE

You may donate less than \$200 and be eligible to receive the state tax credit in the amount of your donation. The amount you donate — up to \$200 (or \$400 per married couple) — will be the amount you may claim as a state tax credit.

For example, if you donate \$200, you may split your donation among more than one public school or more than one activity. Just send your check, along with the mail-in form, to the school(s) of choice.

MONEY WHERE IT NEEDS TO GO

Contributions that are eligible for a tax credit are donated directly to schools, not to the state, and not to the school district.

The funds are not subject to the revenue control limit that prevents schools from spending more than a fixed amount for programs. Your donation will go exactly where you want it to — immediately helping more students become involved in extracurricular activities.

FREQUENTLY ASKED QUESTIONS

What if I don't have \$200 to donate all at once?

A: You don't have to give the full \$200 all at once. The tax credit donation can be contributed in increments throughout the current calendar year. You don't have to give all \$200 to one school. Portions of the Tax Credit can be donated to several schools.

Remember you can donate up to \$200 per single person and up to \$400 per married couple.

How does my contribution help the kids?

A: It helps students participate in our extracurricular programs and other activities that enrich their education and provide them with valuable life experiences. YOU can specify the program you want to help, or better yet, let your donation help the school with the greatest need.

With all of this money being donated, should this fix all the money problems with the schools?

A: Keep in mind that the tax credit can only be used for extracurricular activities. The tax credit cannot be used for teacher salaries or other maintenance and operations expenses.

For you to be eligible to receive the credit for this year, schools must receive your donation by April 15. You have the option to claim the tax credit in either the previous tax year or in the year the contribution was made. Use the mail-in form to send your check today!
