

Minuteman Regional High School Staff COVID-19 Acknowledgement

In order to support the health and safety of the Minuteman school community, we are following the Center for Disease Control (CDC) and Massachusetts Department of Public Health (MADPH) guidelines to protect the students and staff during the COVID-19 pandemic. Staff must monitor themselves for symptoms daily prior to work. Everyone must do their part to protect others and not come to the school if they are exhibiting any COVID-19 symptoms or are feeling sick. Consistent with the District's COVID-19 guidelines, all staff must acknowledge and comply with the terms of this form.

- I agree to immediately inform the Office of Human Resources and will not come to the school if any of the following apply to me:
 - I have any COVID-19 symptoms. Below is a list of possible symptoms for which staff must self-monitor:
 - Fever (100° Fahrenheit or higher)
 - Chills or shaking chills
 - Cough (not due to other known cause, such as chronic cough)
 - Difficulty breathing or shortness of breath
 - New loss of taste or smell
 - Sore throat
 - Headache when in combination with other symptoms
 - Muscle aches or body aches
 - Nausea, vomiting, or diarrhea
 - Fatigue when in combination with other symptoms
 - Nasal congestion or runny nose (not due to other known causes, such as allergies) when in combination with other symptoms.
 - I have been in contact with a person who has been diagnosed with COVID-19 within the past 14 days and have not received a subsequent negative test result.
 - I am currently under instruction to quarantine or isolate due to possible COVID-19 exposure.
 - I have a pending COVID-19 test.
 - I have traveled outside the United States within the past 14 days and have not received a subsequent negative COVID-19 test result.
 - I have traveled domestically within the United States by car, commercial airline, bus or train, etc. within the past 14 days for a non-exempt reason to any restricted states as set out under the Massachusetts COVID-19 Travel Order, which may be amended from time to time, and have not received a subsequent negative COVID-19 test result.
- If I am unable to come to school for one of the above reasons, I understand that to return to the building I will need to show proof of a negative COVID-19 test or quarantine for 14 days.
- I understand that I will be expected to wear a mask at all times while in the building (except during scheduled mask breaks).
- I understand that I will be expected to maintain 6 feet of social distance from others at all times while in the building, although DESE guidance may allow for 3 feet of social distance with masks in specific CTE program areas.
