Include any adjustments since last year's certification; exclude one-third over-appraisal corrections from these adjustments. <p><b>2. 2015 tax ceilings and Chapter 313 limitations.</b></p> <p>A. Enter 2015 total taxable value of homesteads with tax ceilings. <b>13. Taxes refunded for years preceding tax year 2015.</b> Enter the amount of taxes refunded by the district for tax years preceding tax year 2015. <b>16. Total value of properties under protest or not included on certified appraisal roll.</b>

The list shows the appraisal district's value and the taxpayer's claimed value, if any, or an estimate of the value if the taxpayer wins. B. 2016 value of properties not under protest or included on certified appraisal roll. The chief appraiser gives school districts a list of those taxable properties that the chief appraiser knows about, but are not included in the appraisal roll certification. These properties are not on the list of properties that are still under protest. On this list of properties, the chief appraiser includes the market value, appraised value and exemptions for the preceding year and a reasonable estimate of the market value, appraised value and exemptions for the current year. New additions to existing improvements may be included if the appraised value can be determined. <b>24. 2016 effective tax rate for ISDs with Chapter 313 Limitations.</b> Add together the effective tax rates for M&O and debt service for those school districts that participate in an applicable Chapter 313 limitations agreement.	\$0.000000/\$100
