



# (General Information)

School districts across the country are receiving American Rescue Plan Elementary and Secondary School Emergency Relief (ESSER III) Funds to help address COVID-19 recovery. Widefield School District 3 is seeking your input to help us plan and prioritize how we will use our ESSER III funding. After a brief overview about ESSER III, you will find a link to a short survey.

### What is ESSER III Funding?

ESSER III funding must be used to meet needs resulting from the COVID-19 pandemic. These funds are one-time or short-term expenditures to address the ongoing impact of the pandemic. The funding is intended to:

- · Safely reopen and sustain the safe operation of schools, and
- Address the impact of the coronavirus pandemic on students in areas such as learning loss and mental health supports.

#### **How much ESSER III funding are we receiving?**

WSD3 has been allocated \$11.2 million in ESSER III funds. From that funding, James Madison Charter Academy (JMCA) is allocated \$111,710.

### How long do we have to use ESSER III funding?

These are one-time funds and should not be used for ongoing costs Because funds much be spent by September, 2024.

Provide mental health services, supports, and related resources for students and staff.

Provide supplies, services, improvements and personnel to help improve environmental health and safety and limit the spread of COVID-19

#### **Continuity of Operations**

Add/retain staff to continue and/or enhance operations and address student needs. One example is funding additional staffing or instructional materials that would result if a transition to eLearning is necessary.


#### **Technology & Digital Tools**


