I. Call to order/Roll Call

IV. Engage New York

Mr. Fugate discussed that as a district, math instruction will come from Engage New York. This new math instruction was implemented on August 20th. Mr. Fugate discussed that he is ordering manipulatives for each class to assist in math instruction.

V. Emergency Plan

Mr. Fugate gave a copy to the council to review and revise. The council completed the first reading.

VI. Elect officers for the 2018-2019 school year

Mr. Fugate discussed that officers for the 2018-2019 school year needed to be voted on. Mary Kay Caudill nominated Tammy Keene as vice-chair for the council, she accepted the nomination and the council voted in favor. Tammy Keene nominated Marlene Hamilton as secretary for the council, she accepted the nomination and the council voted in favor.

VII. Guided reading

Paige Beasley, District Literacy Coach, came and discussed Take 5 as a guided reading approach during a coaching session. She discussed that each step should be taught, to ensure that each student understands the process. Guided reading with stations will begin on October 1.

VIII. Approve Homework Policy

The council reviewed the Homework Policy. Marlene Hamilton made the motion to accept the 2nd reading of the policy and to adopt it. Leah Lovins seconded the motion, with all members voting in favor.

IX. Approve Principal selection policy

The council reviewed the Principal selection policy. Tammy Keene made the motion to accept the 2nd reading of the policy and to adopt it. Mary Kay Caudill seconded the motion, with all members voting in favor.

X. 1st reading of the Supervision policy

Mr. Fugate explained that he applied for the prestigious Steele-Reese Grant and was very happy to report that MRC had received the grant for the 2018-2019 school

year. The grant will be used to purchase Reading Plus for more advanced readers and Lexia reading program for new/struggling readers.
