



Breathitt County Schools COVID-19 Operations Plan Safe Return to In-Person Instruction Plan

In order to ensure the health and safety of our students, our employees, and their families during the 2021-22 school year, the Breathitt County School District will adhere to guidelines set forth by the local health department, CDC, the Governor's office, and the Kentucky Department of Education.

Students benefit from in-person learning, and safely returning to in-person instruction is a priority. The first day for students was August 11, 2021.

The following procedures will be put into place to ensure the health and safety of our students, staff, and community:

- **SAFETY**
 - All students, teachers, staff, and household members 12 years and older are encouraged to get a COVID-19 vaccination.
 - Students, teachers, staff who have a fever and/or symptoms of COVID-19 should remain at home.
 - Air purification systems are in place in all schools and classrooms.
 - Masks must be worn while students are on the bus.
 - Masks will be required for all students and staff while indoors. Masking requirements will be updated as changes are recommended by the CDC and KY Department of Public Health.
 - Visitors to school facilities will be required to wear a mask while indoors.
 - Masks are not required while outdoors.
 - Temperature checks of students and staff will be conducted on a daily basis.
 - While in classrooms, students will be seated 3 feet apart when possible.
 - Each school will follow procedures for cleaning and disinfecting the facility regularly.
 - Hand sanitizer will be readily available in all school facilities.
 - The schools and district will continue to work with the local health department to facilitate case investigation and contact tracing.

In the event of a resurgence of COVID-19 cases that impact school in Breathitt County, the following procedures will be put into place to ensure the health and safety of our students, staff, and community:

- **SAFETY**

- Students, teachers, staff who have a fever and/or symptoms of COVID-19 should remain at home.

- **INSTRUCTION**

- Students who are quarantined due to COVID-19 exposure will participate in virtual learning that is based on a synchronous school day. Students will attend all classes using the Google Classroom and Google Meet platforms during intermittent school closures.
- In the event that a resurgence of COVID-19 cases results in intermittent school or classroom closure, all students will participate in remote virtual learning that is based on a synchronous school day. Students will attend all classes using the Google Classroom and Google Meet platforms during intermittent school closures. (Temporary remote instruction days)
- In the event that a resurgence of COVID-19 cases results in reduced capacity at the schools, students and families will have the following options:
 - **Virtual Learning Academy option** utilizing evidence-based digital programs. Students will receive online support from teachers with the virtual learning academy option.
 - **Hybrid option** that includes both in-person instruction and online learning days. Groups of students would be scheduled to attend in-person classes on a rotating schedule that will be provided prior to the first day of school. On days when students do not attend in-person classes, they will complete work online that is supported by the teacher.
