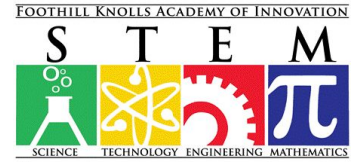




**Upland Unified School District

Chromebook Take Home Pilot Program**



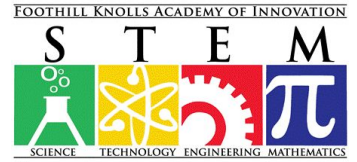
The Upland Unified School District is committed to making educational activities available to all students without regard to their families' ability or willingness to pay fees or request special waivers. (Education Code 49010-13.) Pupil fees may be assessed only as permitted by law and District policy.

Pursuant to the Pilot Take Home Chromebook program, UUSD will make Chromebooks available, free of charge, to 5th, 6th, 7th and 8th grade students enrolled in the Foothill Knolls Stem Academy of Innovation. All students who receive a Chromebook under this program agree to abide by the following.

1. All students who receive a Chromebook shall abide by the UUSD Student Acceptable Use (Computer/Internet) policy. (See Board Policy / Administrative Regulation 6463.4.)
2. Students will bring their Chromebooks to school each morning with the battery fully charged.
3. Students will exercise all due and reasonable care in handling and use of the Chromebook. As part of this responsibility, students will, among other things:
 - a. Transport their Chromebook to and from school in a UUSD-provided protective sleeve or case and will store the Chromebook in a secure location when not in use.
 - b. Keep their Chromebooks clean with no attached stickers or other items that might deface or damage the Chromebook finish, screen, or other components.
 - c. Monitor the condition of the Chromebook and immediately report any and all malfunctions, damage, or loss of a Chromebook to a classroom teacher or technology support staff member. This includes, among other things, a virus or other malware detected on the device.
4. UUSD accepts and acknowledges the reasonable and normal wear and depreciation in value of the Chromebook. The student accepts and acknowledges responsibility for damages when: (1) damage to the Chromebook is intentional; and (2) the Chromebook is stolen from an unsecured car or locker, or unattended bag.
 - a. If a Chromebook is stolen, the student must file a report with the appropriate law enforcement agency within 48 hours from the time the student has or reasonably should have knowledge the device is lost or stolen. The student must also report the stolen device to school officials. To receive a replacement Chromebook, the student must provide a copy of the police report to the UUSD administration.
 - b. Optional private insurance will be made available for purchase, at parent's expense, to cover any costs incurred due to damage, theft, or loss.
5. No student shall attempt to modify, reconfigure, install software, or repair the Chromebook. Any modifications, upgrades or repairs made shall become UUSD property.
6. Students will use their Chromebook solely for school-related purposes that teachers have assigned or approved. Inappropriate uses include, but are not limited to, those set forth in the UUSD Student Acceptable Use (Computer/Internet) policy. (See Board Policy / Administrative Regulation 6463.4.) If a student is unsure whether a use is inappropriate, he or she shall consult with a teacher or parent/guardian before engaging in such use.
7. UUSD has the right to monitor the use of UUSD systems for improper use without advance notice or consent.
8. Students will only use UUSD-approved wireless network connections at school and will not

- connect to any cellular network or non-UUSD wireless access point while at school.
9. Unless part of a school project and with the knowledge and express approval of a staff member, students will not use email, instant messaging or log into chat rooms or online forums during school hours.
 10. The student has no ownership, interest in, and no right to title in the Chromebook.
 11. Students who are in material breach of this agreement and/or who deny any of the UUSD ownership rights to the Chromebook may be subject to disciplinary action and/or referral to law enforcement.
 12. Indemnification: The student and parent/guardian agree to reimburse and hold UUSD harmless from and against any and all liabilities, costs, and damages (including attorney fees) which arise out of or relate in any way to the use of, misuse of, or failure to return the Chromebook.

I understand and will abide by the provisions of this agreement. I understand that any violations of the above provisions may result in disciplinary action, the revoking of my technology access privileges, and appropriate legal action.
