- plan for inservice day- one page reference. PTA would like to help with that. Modereger cleaned out the storage unit and donated centers and supplies to Kindergarten and first grade.

January 24th is when these members get voted in. Honorary service awards- received in February. Nominees go to a banquet. Needed- Art day committee person. Information table for parents. Give handouts to them.

Safety will have an opportunity to prevent at staff meeting about upcoming drills and make sure some drills are during non-instructional times. Change of command- who is in charge when Principal and VP are gone.? Parent night for safety plan suggestion. SSC looks through the safety plan and team to give feedback if there is anything to include. After we read the plan what are the key takeaways from the safety plan. District wants the SSC input. On page 9- Approximately 53% of our students are listed living with others- that % is from last year. Mrs. Modereger will get SSC the new percentage. SSC team read over the safety plan and per via

email will respond if Team members would like to change something. Jalene made a motion to email about any changes in safety plan. Rivas seconded that motion. All were in favor.
