**Title 1 Funds:**

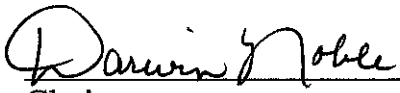
Mr. Noble reported that at this time there is approximately \$8000. The council discussed using the remaining funds to hire tutors to assist in reading and math interventions

Mary Kay Caudill made the motion to move the funds to hire tutors. Tammy Keene seconded the motion, with all members voting in favor.

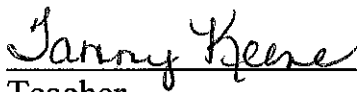

There are three applicants for the position of Title 1 Tutors.

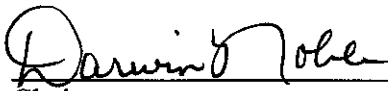
Chris Banks made the motion to go into executive session at 1:34 PM. Marlene Hamilton seconded the motion with all members voting in favor.

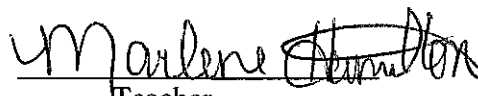

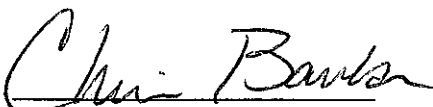

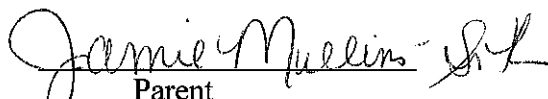
