New Student Application Fee. This **non-refundable** fee is required for all new students and pays for processing a student's application to Bellevue Christian School (BCS). The fee is paid online when making application.

Enrollment Fee. This annual fee is in addition to tuition and places the student on the school roster, thereby confirming their enrollment at BCS preschool. The fee is **non-refundable** once billed or paid. Returning families must clear account balance to be eligible for enrollment.

Annual Tuition

- May be paid in full by May 1 with a 2% discount if paid by check (offer expires May 2).
- May be paid in full by May 1 by credit card* or wire transfer (no discount, no credit card or wire fees; fees apply beginning May 2). ***To avoid card convenience fee, credit card must be run through school and not VC Pay. Contact Student Billing for details.**
- May be paid in 10 monthly installments beginning May 1, 2022 and ending February 1, 2023 by ACH managed by BCS, VC Pay, or bank bill payment. Not eligible for pay in full discounts.

Other Preschool Fees.

- Fees for field trips may be charged. Fees run from \$5 to \$20.
- Extended Day drop in: \$12 per hour (\$5 minimum) added to monthly tuition statement. With advance notice, an AM student can stay until 3:00 pm, on space availability. All payment terms apply. Prepayment discount is not available.
Late fee: \$20 for 5-10 minutes late; thereafter \$20 for each 10 minutes late (no proration). Late pick-up fee is billed on statement.

Payment Terms

- Payments are due by the 1st of the month; payments via ACH will occur on the 5th of the month.
- Account balances that are paid by the 5th of the month will avoid late fees.
- Account balances paid between the 6th and 20th will be subject to a \$15 late fee.
- All payments made after the 20th of the month will be subject to an additional \$50 late fee.
- Any check or ACH that is returned for any reason will be subject to a \$25 fee.
- Bank and card payments made through VC Pay will be subject to convenience fee.
- Student may not attend classes or participate in any school activities beginning the first day of the following month, if the previous month's balance is not paid.

Force Majeure. In the event of school closure beyond the school's control, the School's duties and obligations will be postponed until such time as the School, in its sole discretion, may safely reopen and/or comply with its duties and obligations. A full description is provided in the online enrollment process.

Withdrawals. If a student withdraws after they have enrolled, tuition and fees accrued through the end of the month of withdrawal are due regardless of the date. Tuition will be calculated based on a 10 month installment plan beginning May 1, 2022. Refunds only for payments made over and above tuition and any fees charged through the month of withdrawal. Tuition responsibility is as follows:

Prior to, and including, April 30	Enrollment fee; any fees incurred through April 30
May 1 through 31	Enrollment fee; May tuition installment; any fees incurred through May 31
June 1 through 30	Enrollment fee; May & June tuition installments; any fees incurred through June 30
July 1 through 31	Enrollment fee; May through July tuition installments; any fees incurred through July 31
August 1 through 31	Enrollment fee; May through August tuition installments; any fees incurred through August 31
September 1 to end of school year	Enrollment fee; any fees incurred and all tuition installments beginning May 1 through the month the student withdraws. No proration of month.
