**Kennewick School District** will ask voters to consider renewing two replacement levies on Feb 8 – an Educational Programs & Operations (EP&O) Levy and a Technology Levy. The current levies, which voters approved in 2018, expire in 2022.

The replacement levies will provide funding for schools through 2026. **These are not new taxes.**

# Local levies support programs and staffing not funded by the state.

The Educational Programs & Operations (EP&O) Levy and state Local Effort Assistance (LEA), also known as levy equalization funding, provide more than 11% of the school district's budget for educational programs and staffing. The levies bridge the gap in funding from the state.

#### Why does Kennewick School District need levies?

There is a gap between what the state funds and what our students need, including funding for school resource officers, nurses, counselors, special education, transportation, technology and other critical program needs.

## What percentage of "yes" votes are needed for approval of the levy?

Levies require a 50 percent simple majority to pass.

### How are tax amounts determined for property owners?

Each property owner pays a different amount of taxes because the assessed value for each property is different. Kennewick School District can only collect the total levy amount approved by voters no matter how much assessed values increase. If property value increases within the Kennewick School District boundaries, the estimated tax rate decreases.

#### Are tax exemptions available?

Yes, if you meet certain criteria. Call the Benton County Auditor at (509) 786-5620 for more information.
