| Protocol of contact- tracing | In schools, after a confirmed case: Continuation of the learning in presence for the students if the self-tests carried out on D + 0, D + 2 and D + 4 are negative. Students who do not perform self-tests are isolated for 7 days and continue their learning at a distance. In middle and high schools, after a confirmed case: Pupils under 12 and pupils aged 12 and over identified at-risk contacts justifying full vaccination continue face-to-face lessons if the self-tests carried out on D + 0, D + 2 and D + 4 are negative. Students aged 12 and over identified as risky contacts and not showing a full vaccination continue the distance learning for 7 days and perform an antigen or PCR test at the end of the isolation. | | | |
