PURPOSE OF ESSER

- Support K-12 schools response to COVID-19
- Address local relief, prevention, preparation, and recovery efforts relative to responding to COVID-19
- Provide resources to address the needs of individual schools
- Improve preparedness and response efforts
- Supplies to sanitize and clean facilities
- Technology needs to maintain educational opportunities
- Mental health support
- Summer learning and afterschool programs
- Maintain the operation of and continuity of services and continuing to employ existing staff







ESSER I EXPENDITURES

Generated through Finance Department

- Personal Protective Equipment hand sanitizer, hand soap, masks, cleaning supplies
- Long Term Substitute Teachers Schools were equipped with a substitute teacher on campus to step in when needed.
- **Day Porters** Schools were assigned an additional custodian to clean surface areas throughout the day in classrooms, bathrooms, cafeteria and bathrooms.
- PVOnline Salaries for increasing number of students opting for PVOnline for their students

Expires September 30, 2022 \$4,500,000 Unused funds carryover to ESSER II



ESSER II EXPENDITURES

- Extended Learning Opportunities Free Summer school programs, before and after school classes
- Creation of PVConnect Provide families with a virtual model for learning
- Free Lunch For All Students
- Funded Educational Programs Literacy, Math, Science, Reading
- Outside Hand Washing Stations and Water Bottle Filling Stations
- Community Education Lost revenue due to all enrichment and academic classes being offered at no cost to families.

Expires September 30, 2023 \$18,500,000 Unused funds carryover to ESSER III



ESSER III FACTS

- Expiration September 30, 2024
- Arizona received \$4 billion in funding for COVID-19 recovery efforts
- \$41.4 million is granted to PVUSD
- All stakeholders must be given the opportunity to provide input for the board
- 20% or \$8.3 million of that money MUST address learning loss
 - Evidence Based
 - Responds to students academic and wellness needs
 - Address disproportionate impact of COVID-19 on sub groups such as low-income families, children with disabilities, and English learners.



ESSER III APPROVED EXPENDITURES

Day Porters - Continue to pay for day porters and custodial services Funded Education Programs - Purchase of materials to support current math curriculum

PVConnect - Staffing and Materials purchased to support the PVConnect model

Providing instructional support to quarantined students
Specialists hired - provide support in addressing learning loss
Teacher shortage - incentive/return to work
Stabilization - loss of 2000 students across district

Replace broken/damaged student Chromebooks from previous year of virtual learning

 Money granted to each PV School to address academic needs due to learning loss
 Each school is receiving funding for the next 3 years to assist in bridging the academic learning gap (approximately \$100,000 per year)
 Continuation of Community Education Programming - All Community Education enrichment and summer school programming were covered through ESSER II and are slated to continue for next summer through ESSER III. Community Education typically assists the district financially by paying for custodial services, campus assistants, Armoured Car Services, etc.

- Specifically addressing learning loss
- Soliciting feedback as the representative from your stakeholder group
- Working with Marketing Department to provide communication on district website
- We have roughly \$4 million to work with in providing recommendations to
