

**Board Minutes**  
**May 15, 2012**

The Johnson County Board of Education met in regular session on Tuesday, May 15, 2012 in the board office at 7:00 p.m. Marty Thompson, Alvin Moorman, Alan Frost, Donnie Carter, and Bill Jackson were present. Chairman Thompson called the meeting to order and welcomed everyone. Mr. Carter gave the invocation and Mr. Jackson led the Pledge of Allegiance to the flag.

The following business was transacted:

1. The proposed agenda was amended to include a time for board member comments. Amended agenda was approved on a motion by Mr. Carter, second by Mr. Moorman; unanimous approval.
2. The April 17, 2012 board minutes were approved on a motion by Mr. Frost, second by Mr. Jackson; unanimous approval.
3. Mr. Thaddeus Mason spoke to the board expressing his disappointment with the recent non-renewal of the middle/high school principal.
4. Mr. Jerronney Darrisaw also spoke to the board expressing his disappointment with the recent non-renewal of the middle/high school principal.
5. Mrs. Teresa Wombles spoke to the board expressing her desire for all seniors to be able to participate in graduation ceremonies regardless of graduation requirements.
6. Superintendent Warnock announced:

Mrs. Thomas thanked all staff members for making the school year successful. Mrs. Thomas and her staff are excited about CRCT results.
13. Mr. Lee Byrd, JCMS/HS Principal, updated the board on activities in his school. Mr. Byrd also discussed CRCT results, upcoming graduation and perfect attendance rewards.
