

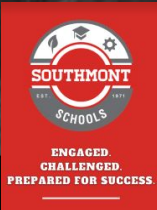

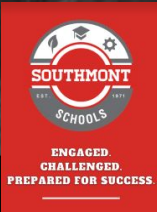
Return to In-Person Instruction Plan

Start of School: Wednesday, August 11

All grade levels will be open for in-person instruction five days per week. Welcome back!

Individuals with Covid positive results will be isolated by the local or state health department for a given number of days following state and local health department guidelines before returning to school. Return to In-Person Instruction Plan

Southmont Schools will follow state and federal mandates.

Currently that means masks for unvaccinated individuals are recommended. Masks must be worn on school bus transportation due to a federal mandate. State and federal mandates may continue to change.

Visitors and Volunteers: Schools will have traditional activities physically open to parents, guardians and the community. All visitors should perform a self-check for COVID symptoms prior to entering.

Clinic: Symptomatic students waiting for pick up will be provided a separate space to wait until leaving the building.

Cafeteria: Lunch visitors will not be permitted at this time.

Water Bottles: Students may bring their own water bottle with filling stations available for refilling.

Distancing and Seating Charts: Students will have assigned seats in the classroom, cafeteria and bus. In the classroom, space will be maximized and students will face forward as much as possible.

Activities and Schedules: P.E. will be held outside when possible and outdoor learning is permitted.

Extracurriculars Events: Distancing between families is encouraged at all extracurricular events.
