There are two individuals serving the duties of the above three positions.

One individual is employed by Sodexo as the Instructor and one individual is employed by Sodexo as Instructional Assistant and Catering Supervisor.

The FSMC charges the District a contracted amount per year for the Instructor position and charges on an ongoing basis for the Instructional Assistant/Catering Supervisor depending on time worked each month. Instructional Assistant cost to Sodexo is approximately \$35,000 per year plus benefits funded with 50% Tri Tech catering revenue, 25% from Tri Tech budget, and 25% by Sodexo.
