# **SURGICAL TECHNOLOGY**

## **(1300 Hours)**

### **2024-2025**

The MNTC Surgical Technology Program provides training and skills necessary to become a surgical technologist. Our goal is to prepare competent entry-level surgical technologists in the cognitive (knowledge), psychomotor (skills) and affective (behavior) learning domains. A surgical technologist is an integral member of the surgical team, responsible for preparation of sterile supplies, equipment and instruments, and assisting the surgeon in their use. The surgical technologist most frequently serves as instrument handler, setting up instruments, and then passing them to the surgeon. A surgical technologist may also assist the surgeon by performing tasks such as retracting incisions, cutting sutures and utilizing suction to maintain a clear field of vision for the surgeon.

*The MNTC Surgical Technology Program is accredited with the Commission on Accreditation of Allied Health Programs (CAAHEP). This recognition means the MNTC Surgical Technology Program meets national standards set for surgical technology education. Only graduates of CAAHEP-accredited Surgical Technology Programs are eligible to take the exam to become a Certified Surgical Technologist (CST).*

### **Who Can Apply?**

The program is open to post-secondary adult students only. Students must be at least 18 years old by the first day of class. Enrollment is limited. Students must meet **ALL** entrance requirements. **It is the applicant's responsibility to be sure their documentation is turned in and complete.**

### **Schedule**

Students will attend class from 9 a.m. – 4:10 p.m. Monday through Friday until clinicals begin. From November – May, students will attend clinicals on Mondays, Tuesdays, Wednesdays, Thursdays and some Fridays from 6:30 a.m. – 3:15 p.m. and attend class on Fridays from 9 a.m. – 4:10 p.m. The program is completed in two consecutive semesters, August through May.

- DAT (Abstract Reasoning) (fee of \$17)
- O'Conner Dexterity Test
- Provide documentation of immunizations, titers, skin tests, OSBI background check, Hepatitis B waiver, and Flu Vaccine Agreement.
- Students must provide own transportation to class and clinicals
- CPR-BLS for Healthcare Providers – **to be taken after acceptance into the program**
- TB Skin Test – to be taken after acceptance into the program
- Drug screening and national background check will be required after acceptance and conducted randomly.

Students must purchase several sets of program-specific scrubs, safety goggles/glasses, and work/clinical shoes. The style, size, and other order information will be provided once accepted into the program. You must purchase the required style and no other types of scrubs will be permitted in class or clinicals.

### Course Description

**Surgical Techniques I:** This course prepares the student to enter the clinical phase of the program. Covered in this course of study is the *basic knowledge* the student will need before assuming the clinical responsibilities of an entry-level surgical technology student.

**Surgical Techniques Practicum I:** This course prepares the student to enter the clinical phase of the program. Covered in this course of study are the basic hands-on skills and *competencies* the student will need to master before assuming the clinical responsibilities of an entry-level surgical technology student. Each of these skills is covered in theory within Surgical Techniques I.

**Anatomy, Physiology, and Pathology:** This course covers the human body in health and in disease. Surgical Pathology is emphasized throughout.

**Surgical Techniques II:** This course covers the techniques and theories of the common surgical specialties and procedures listed below. Surgical pathology and anatomy will be reviewed throughout.

**Surgical Techniques Practicum II:** This course is all clinical in nature and setting. The student will be assigned to specific clinical sites and will be directed by the clinical preceptors of that facility as well as being monitored by the MNTC faculty. They will be actively using the skills and knowledge they acquired in the classroom and laboratory in a real operating room setting.

**Surgical Techniques III:** This course covers the techniques and theories of the common surgical specialties and procedures listed below as well as addressing special needs patients, contemporary issues in present day surgery, and the preparation of a resume, cover letter and interviewing techniques. Surgical pathology and anatomy will be reviewed throughout.

**Surgical Techniques Practicum III:** This course is all clinical in nature and setting. The student will be assigned to specific clinical sites and will be directed by the clinical preceptors of that facility as well as being monitored by the MNTC faculty. They will be actively using the skills and knowledge they acquired in the classroom and laboratory in a real operating room setting.

**Medical Terminology:** This semi self-paced, independent study course presents a study of basic medical terminology. Emphasis is placed on spelling, definition, usage and pronunciation.

### **Federal Financial Aid**

Federal Financial Aid is available to adult students attending a 600+ hour program at MNTC. A high school diploma or equivalent is required to apply for financial aid. The programs eligible to participate in Student Financial Aid (SFA) funds are approved and accredited by the Oklahoma Department of Career and Technology Education (ODCTE). For a complete list of approved programs, contact the Financial Aid office.

### **Federal Financial Aid Programs Offered at MNTC**

The following are the financial aid programs available, if a student qualifies:

- Oklahoma Tuition Aid Grant Program (OTAG): This program is administrated by the Oklahoma State Regents for Higher Education.
- Federal Pell Grant (Pell) Program: This is a need-based program, and eligibility is pre-determined by the Department of Education.
- Federal Supplement Educational Opportunity Grant (FSEOG) Program: This program is offered to students based on need. To qualify for FSEOG, the Expected Family Contribution (EFC) must be zero. The funds will be awarded to the students who have completed their application and been accepted until funds are exhausted.

**MNTC's:** MNTC's Surgical Technologist program was established in 1998. To date, all of our graduates who have attempted to obtain employment have been hired as surgical technologists prior to or within six months of graduation.

**MNTC's:** We accept 20 *qualified* applicants per year. Small classes allow for frequent one-on-one attention from the instructors and adequate clinical opportunities. We have had an 82% retention rate for the past 20 years.

**MNTC's:** MNTC's tuition and fees include textbooks, workbooks, study guides, core syllabus, jacket and picture ID badges. Each student receives a membership to Heath Occupation Students of America (HOSA), the Oklahoma State Assembly (OKSA) and the Association of Surgical Technologists (AST). The AST provides discounts on conferences and a monthly magazine, and HOSA provides leadership opportunities along with state and national competitions. **7. Is the school and the program accredited by the agencies that make policies for surgical technology? And why is accreditation important to the student?**

**MNTC:** We are fully accredited by the Oklahoma Department of Career and Technical Education (ODCTE), the Oklahoma State Department of Education and specifically for surgical technology by the Commission on Accreditation of Allied Health Education Programs (CAAHEP). *Only* graduates from programs accredited by CAAHEP are eligible to take the national certification exam offered by the (NBSTSA). Many employers are demanding that their surgical technologists become certified, and in the case of an entry-level surgical technologist, they use certification as a requirement for new hires.

**8. How can I be absolutely sure that a program is accredited by the *proper* agency?**

**9. How do I know if the program has adequate supplies and equipment for practice prior to being sent to a clinical setting?**

Ask to see the lab facility. It should have a specialized “scrub” sink, operating table, stainless steel back table, mayo stand, and kick bucket. There should be a large variety of surgical instruments to provide hands on-memorization and passing skill. Ask to see their supply of gowns, gloves and assorted drapes.

**MNTC:** We have a large lab with two (2) complete simulated operating room suites. We have hundreds of instruments and shelves full of gowns, gloves, drapes, etc.

## Surgical Technology Program Immunization / Screening Requirements

The following documented immunizations, titers and records must be submitted prior to acceptance in the **Surgical Technology Program**. You must submit documentation to the Health Education Office.

- Measles, Mumps, Rubella (MMR)  
You must have documentation of receiving two (2) MMR vaccinations, **or positive titers** (blood tests that show immunity to Rubeola, Mumps and Rubella). If any titer comes back as negative, you will need to have the vaccine administered.
- Hepatitis B Waiver  
You **MUST** have a **signed declination** statement **before** being accepted into the program. **The Waiver/Release From Any & All Liability By Students form on page 18 meets this requirement.**
- Declination Statement  
"A written statement from a licensed physician indicating that a vaccine is medically contraindicated shall exempt a student from the hepatitis B and/or measles, mumps, and rubella vaccinations. Students may also obtain exemptions to the hepatitis B and/or measles, mumps, and rubella vaccinations by submitting a written signed statement declaring that the administration of vaccine conflicts with the student's moral or religious tenets or, if the student is a minor, the student's parent or guardian provides a written statement that the administration of the vaccine conflicts with the parent's or guardian's moral or religious tenets."
- Tuberculosis Skin Test  
If accepted, you will be required to receive **two (2) negative TB (PPD) skin tests 7-21 days apart between June 2024-August 2024**. For positive reactors, you must show proof of the positive reaction and then have a negative chest X-ray. *Be sure to get your TB skin test prior to taking any other immunizations or you will be required by your physician to wait one month after receiving a vaccine such as an MMR.*
- Varicella Immunization  
You must have documentation of receiving **two (2) vaccinations**, or have a **positive titer** (blood test showing immunity to Varicella). Submitting a physician's statement that you had chicken pox will **NOT** be accepted.
- TDAP (Tetanus) Vaccine must have documentation of receiving a booster immunization no later than June 2016.
- HS transcript or High School Equivalency Test  
International students must provide documentation of HS completion.
- Minimum ACT/SAT score or Accuplacer scores, or college transcripts ACT (composite of 19 or > residual scores are permitted) **or** SAT (composite of 980 or >) **or** Next Gen Accuplacer scores of: Reading 246+, Writing 250+, Arithmetic 238+ or Quantitative Reasoning, Algebra and Statistics (QAS) 238+ **or** 12 hours college credit with 2.5 GPA

- DAT (Abstract Reasoning) score Percentile Ranking Score
- OSBI background check
- Seasonal Flu Vaccine signed agreement located on bottom of Waiver/Release From Any & All Liability By Students Form on page 18. Flu vaccine will not be required until closer to time of clinicals.
- COVID -19 Vaccine For participation in clinical programs, MNTC does not require students to be vaccinated against COVID-19. However, certain health care facilities participating in clinical rotations require students to be fully vaccinated prior to participating in clinical rotations at their sites.

If you will be participating in a clinic at a facility that requires COVID-19 vaccination, you will be provided information regarding specific COVID-19 vaccination requirements for the clinic.

- Medical Marijuana Students are subject to drug testing at any time after program admittance, or at any time if a reasonable suspicion arises. Students may be denied admittance into the program, denied clinical experience, or be dismissed from the program for testing positive on a drug screening. It is important to understand that even if a student has a prescription for a controlled substance or other medication that impairs physical and/or cognitive ability, the student may be removed from the clinical setting or even the program, if the safety of others is at risk.

Per federal regulations, medical marijuana remains a drug listed in Schedule I of the Controlled Substances Act. Holding a medical marijuana license will not exempt students from a required negative drug screen to enroll in the program or participate in the clinical experience.

## **OSBI Background Check Information**

As a part of the MNTC Surgical Technology Program, you will be required to practice your skills in facilities requiring background checks. Before you can be assigned to a hospital, clinic or other facility for your clinical or externship experience, you must have a background check that includes a sex offender check. If your criminal history is positive, the facility will then review your personal criminal history background. Each facility has the right to accept or reject any student based on information shown in the criminal history background check. MNTC cannot overrule the decision of the clinical or externship sites. Criminal offender, sex offender and violent offender reports must be obtained no earlier than January 2024. All three boxes must be checked on your OSBI application. Fingerprints are not required.

**An applicant, whose background check does not come back clear, will be considered on a case-by-case basis, for admission to the Surgical Technology Program.**

If you have lived in Oklahoma less than one year, you must submit the information from the state where you previously resided as well as the OSBI report. These reports must also include information regarding sex offender history.

It is your responsibility to obtain your record from the Oklahoma State Bureau of Investigation (OSBI) and provide it with your documentation. The OSBI has an online search system called Criminal History Information Request Portal (CHIRP) at <https://chirp.osbi.ok.gov/>. This system uses credit card or electronic transfer of funds to access all three required reports costing \$20, which you can print instantly.

If you need to go in person, the OSBI office is located at 6600 North Harvey, off NE 63<sup>rd</sup>, Oklahoma City, OK, one block west of Broadway Extension, Building 6, in the Broadway Executive Park. The telephone number is 405-879-2689, extension 0. The cost is \$19; OSBI accepts cash or credit card. They will not accept checks. You will be required to bring your Social Security number, date of birth, full name and payment with you to be able to complete the process. A sample form is located on the next page. If you are a MNTC HIRE student, the DHS background check with this program will **NOT** meet the requirements for this program. See HIRE Coordinator with any questions.

Another background check (nationwide) and drug screening will be required shortly before the clinical phase of the program begins. A positive result on either may deny you entry into any clinical sites and henceforth graduation from the Surgical Technology Program.
